



It is so hard for me to think back and discuss what happened. I feel so sick and gross inside when I think about it. This is something I've bottled up inside me for so long because it embarassos me as much as it feels humiliating. Well, I'll do my best to tell their side of the story through my eyes as I saw it.

I've known al La Badie for about 10 years threw scouting. I've worked on numerous scouting activities with him, anything from camporees to summer camps and troop activiti

Of was very generous with his time for scouting and amoungest his numerous activities one was counseling merit badges. Of counseled a couple different merit badges but the one most of the boys were involved in was differential. We all went to all because he was easy going and he had a pool at his apartment in Huntington Beach which we used.

Sometimes when we were finished working on the merit badge all of we would go back up to his apartment. When your at the age of 12,13,14 and you're with your buddies

a lot of the talk is about sex, or who is the toughest, et. when all put a dirty movie in the VCR. we really didn't know what to say, but we watched it because we were courious as to what men and women did while having sex. It seemed that a lot of the discussion between all and us boys was about sex. One time I remember him asking us certain questions about our mon's and dads and what we thought about them doing different sexual asts. To each other.

about 3 or 4 years ago al was called on the carpet for showing us there movies and I was too scared to mention anything else that happened so I sort of buried it deep inside me and hope it would never come up again.

al was a very good friend of the family and he would come over to the house a lot and ask my parent If I would do evands or go places with him. My parents said it was okay and I was glad to get out of the house We did lots of things together, go to the swapment, carnivals, amusment parks, all kinds of different things. I had a lot of fun because in a large family which I!

from, we didn't do family things like that because it would cost a fortune. I guess I liked being spoiled because live never felt it before.

I found it easy to talk to al, he always listened and seemed like he understood my problems in life (family problems). Sometimes we would sit in his jucusze for a while then we would decide it was getting late and I should get home. When we would go back to his room it seemed like a movie would be place in the VCR and going home seemed to far away.

a game, kind of foreplay I guess, would start. The jucuryzi, the movie, then he would give me a back out or he would ask me to give him one. Sometimes if I was dressed he would start to undress me. It layed in his bed watching this movie with him 121 rubling my back, them my legs, then he would turm me over on my back and start rublin my chest then slowly start caressing my genitals. On two occations he started bising then sucking on my penis, I didn't know what to do. I layed there flat on my back unable to move. I wanted to get up but I felt like I was trapped. I was seared that something would happened to

me. I thought of my parents but how could I tell them. This is when I decided to forget what happened a put it out of my mind.

Ofter that I bind of seperated myself from DI. I wouldn't let him hug me or let myself do things alone with him anymore the would ask me to do things with him but I always made sure I wasn't alone there was always a briend with me. I knew this would be safe because he never tried to do anything when a big group was around. I guess he got a him because he stopped asking me to do things and then he stopped coming over to the house.

Errom then on al and I only saw each other at sheetings or just spoke on the phone about scout things nothing else. happened between us. I don't know why I didn't say anything earlier I guess I was just glad it stopped
