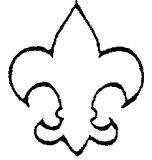
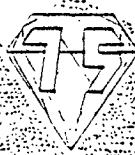

Dear Paul,

ALFRED CARL WHITACRE, JR. is not currently registered with the Mt. Diablo Council as a volunteer. No formal charges were filed against him, however, during the investigation of the STEVEN KABEARLY case, several questionable activities of Carl Whitacre were noted. Specifically, he was the second adult on several troop outings when molestation by Kabearly occurred.

Evidence presented by the scouts indicated that nudity was permitted on outings when Carl was present. Also, there was much open joking and play with clear sexual implications between the scouts and Kabearly which Carl permitted.

As a result of the information gained from the Kabearly investigation, it is my recommendation that Alfred Carl Whitacre, Jr. not be registered as an adult leader in scouting.

This supplements my secretary's memo of September 20, 1990.

While reviewing the litigation file involving allegations of sexual abuse by Steve Monroe Kabear, I came across two additional references to Karl Whitaker. The first document is page three of a summary dated October 31, 1988 which is included in the criminal investigation file. The notation dated October 6, 1988 again makes reference to the call from Mrs. [REDACTED]

The second document is page five from criminal case 87-1503. Third paragraph from the bottom includes an allegation by one of the youths that Karl Whitaker asked the youth for a "bug" during a ride home from a Boy Scout meeting.

P.D. to handle the matter in CCC. [REDACTED] viewed "porno" movies once or twice. Nothin else. After speaking w/ [REDACTED] discovered photographs of [REDACTED] and talked to several people who kept referring him back to [REDACTED]'s last incident 6/88 after [REDACTED] came home from local drug rehab. center. [REDACTED] said he was never touched in a sexual manner.

KOIRALA, KABEARY shows porno movies. Incident was probably 6/88.

WARNOCK informed KABEARY had been seen around Albany High School in the past few days. The KABEARY's presense may intimidate potential witnesses. KABEARY told members of Troup 22 he is a former member of the "Green Berets" trained to kill and a former Berkeley Police Officer.

During the search of 1049 Vetern's Court, Martinez, Officers GARCIA and WARNOCK seized 4 photographs [REDACTED]'s in the nude, found slides negatives and photographs along w/slide projector, movie camera, Playboy magazines, movie projector.

Mrs. [REDACTED] called, claims to have reported an incident in 1983 involving her son, KABEAR and Carl WHITAKER. Her son was molested she reported it, nothing done, son threatened if he talked to authorities. Says her husband is a sheriff, he may do something to KABEARY he finds out.

Steve wants him to come over, he comes over takes their cloths off.

10/07/88 Ofc. Garfield and I reviewed evidence which was seized from KABEARY'S residence. During the review, negatives showing young boys in simulated sexual positions. The photos simulated are; attempted oral copulation and attempted anal intercourse.

Slides which were seized from KABEARY'S residence were also reviewed. These slides all show a white male juvenile who appears to be masturbating.

These negatives and slides are to be submitted for photograph prints.

10/07/88 1300 Received photograph prints which were made from negatives which were seized at KABEARY'S residence.

The photographs apparently were taken at a camping trip during the winter months. It appears as if there is snow on the ground in the pictures.

I was only able to identify two of the subjects in the photographs. One of the subjects is KABEARY and the other subject [REDACTED]. There are other subjects in the photographs I did not recognize.

As [REDACTED], Jim had offered any assistance in the past, I asked him to meet me at Kensington Police Department.

10/08/88 I arrived at work and found a note from Sgt. Mevin #3. Sgt. Mevin talked with the subject the night prior who did not want to leave his name. (See attached note). Sgt. Mevin felt that the subject on the telephone was [REDACTED], a reported victim of KABEARY.

As the subject requested a meeting, I met with the subject at Albany Middle School. From the conversation, I could tell that the subject I was talking to was [REDACTED]. The subject did not want to give me his name although he had asked if I had reviewed his statement had given to Ofc. Garcia.

I advised the subject that I had reviewed the statement. The subject provided the same information along with some additional information.

The subject stated that while he was at KABEARY'S residence and KABEARY was masturbating, KABEARY asked the subject if he wanted to sit on KABEARY'S lap. Apparently the subject refused and nothing else was stated.

The subject also had stated that he lives [REDACTED] from WHITACRE, Karl. I stated that WHITACRE had given him rides to and from Boy Scout meetings. The subject stated that during one of these rides, WHITACRE asked the subject for a "hug". When I asked what the hug consisted of, the subject stated that WHITACRE puts his arms around his neck and the subject put his arms around WHITACRE'S waist.

I asked the subject if he knew of anyone else who may have had some contact with KABEARY. The subject stated that a friend of his by the name of [REDACTED] had confided in him. Apparently [REDACTED] had a similar incident as the subject's. [REDACTED] will be contacted at a later date.

After talking to the subject at Albany Middle School, I met with [REDACTED] at Kensington Police Department. I asked [REDACTED] if he could name some of the subjects in the photographs which are in his possession.

Enclosed is the information sheet on Karl Whitacre. Also enclosed is the copy of a police investigation which reported "Unfounded" to a report of sexual abuse of his daughter.

During the investigation of the Stephen Kabearny case, I checked with the investigating officer Lt. St. Onge, as to the involvement of any other adults in the Kabearny case. Lt. St. Onge reported that, after talking with all of the identified victims, it appeared that no other adult was involved in the activities with Kabearny. I specifically asked about any suspicions regarding Karl Whitacre and Lt. St. Onge stated that none of the victims had implicated Whitacre.

In your letter you indicated that Whitacre may have been involved in a molestation situation. If we can assist in following up on the report, we will do so. As of this date we have not received any complaint from a scout or parent as to Whitacre molesting a child.

Subject of this report, [Redacted], a white female juvenile; 11 years old, confessed to [Redacted] and [Redacted] that she had been sexually active with her father for the past two years. This included intercourse and oral copulation. Her father's sexual advances started approx. two years prior on a camping trip and subsequently as a continuing problem. The victim was sworn to secrecy for fear of divorce of the victim's parents.

On 7-24-83 at approx 1245 hours the above RP/ [Redacted] landwired the Albany Police Dept requesting to speak with an officer regarding a possible sexual relationship between a 9-year old female juvenile and her natural father. RO met with Mrs. [Redacted] at her residence located at [Redacted], Berkeley, Ca. On arrival Mrs. [Redacted] explained to RO that her daughter was 11 years old, and with two of her playmates were sharing secrets at which time one of the playmates confessed to having a sexual relationship with her father for the last two years which included intercourse. Mrs. [Redacted]'s daughter was present during the time and was introduced to RO and the above [Redacted].

[Redacted] who is 11 years old stated that several days prior she was introduced to the victim who was verbally identified as [Redacted], 11 years old, by a mutual friend who was identified as the above [Redacted] of [Redacted] Ave., Albany. Ms [Redacted] stated she has known [Redacted] for approx. two years, subsequently developing a friendship. Apparently [Redacted] had known the victim for approx. two years and had just introduced the victim to [Redacted] several days prior.

Ms [Redacted] continued explaining that she, [Redacted] and the victim [Redacted] approx. three days prior were over at [Redacted]'s residence. [Redacted] stated that all three girls were in a secret room inside [Redacted]'s residence. The secret room is accessible only by a small crawltthrough doorway located in the bathroom which leads into a larger room of the approximate size of a kitchen nook.

Apparently all three juveniles entered the secret room and were sworn to secrecy, then began telling their bad experiences. At that location the victim first listened to [Redacted] and [Redacted] confess their closely guarded secrets. Both [Redacted] and [Redacted] had asked the victim to relate her worst secret and the victim, still a little hesitant, again made [Redacted] and [Redacted] swear to secrecy because if anyone knew of the secret the parents would get a divorce and they are apparently in veritable combat.

The victim at the time told her friends, the above RPs, that her father "does it to her". The victim related that her father first started doing it two years prior when

she was 7 years old while the family was on vacation in Lassen.

Apparently the other family members went on a hiking expedition at which time the father stayed in camp to prepare dinner. The victim retreated to a tent to rest and a short time later her father entered thinking she was asleep. The victim pretending she was asleep observed her father disrobe and started rubbing his penis all over her body. The victim stated that now her father, when they are alone in the house, asks the victim if she "wants to play". She knows what that means and tells her father, No, and subsequently leaves the room to another part of the household. A short time later her father goes to the victim, picks her up and carries her to his bedroom, takes off her clothes, then his clothes and puts her under the bed covers.

Ms [redacted] continued stating to RO that the victim related that her father then rubs his penis on her bones at which she started pointing to her vaginal area.

The victim stated apparently that it has been quite a while since the father has made his advances and she expects him to make another advance toward her in the near future. It was determined that it has been all of two weeks since the last episode of a sexual encounter with her father.

RO asked [redacted] what she thought the victim meant when she stated, "My father does it to me." [redacted] related that it was the same thing as the F for the kids didn't use the word F and they say "do it" instead.

[redacted] stated that at first she didn't know whether to believe the victim or not, so she and her friend, [redacted], the other reporting party, went to see the victim's older sister who is 11 years old. The two RPs subsequently asked the older sister the validity of the victim's statement at which time the sister stated it was not true for she was only trying to get attention. Apparently at that time [redacted] stated that she believed the victim because she told the same story before regarding the father's sexual relationship and the victim's sister apparently became agitated and nervous and appeared to be a little afraid.

It was felt by [redacted] that the victim's sister could also have been involved in a sexual encounter with the father.

The interview was terminated and [redacted] was advised at that time not to tell anyone what she had reported to RO, at which time it was agreed by her and her mother.

Telephonic contact was made with [redacted]'s residence, the other person present during the confessing of the victim. RO spoke to Mrs. [redacted] and briefly explained the reason for the landwire contact and was immediately invited into the home for the purpose of interviewing the daughter.

[redacted] confirmed the story reported by [redacted] earlier. [redacted] also stated that she knew the victim for approx. two years and had recently introduced [redacted] to the victim. [redacted] also was concerned over the reporting of the incident for she was also sworn

to secrecy. After a brief discussion regarding "good and bad secrets" [redacted] stated that the victim first advised her of the sexual advancements approx. one year prior pertaining to the vacation at Lassen. [redacted] was told by the victim that she has intercourse with her father and also engages in oral copulation with some frequency.

[redacted]' mother and father who were both present during the interview with their daughter, at which time [redacted]' mother stated that approx. one year prior the daughter had told her that the victim's father was having a sexual relationship with his daughter. However Mrs. [redacted] did not believe the daughter and failed to report the incident to the proper authorities.

ATTN: Detective Division.

In a limited investigation it was found that the victim's parents are both employed. Her mother is employed as an attorney and the father works at Judson Steel. The victim made both RPs swear to secrecy regarding the sexual encounters with her father for fear of divorce, for her parents were not getting along now and arguing frequently.

Apparently there are three daughters in the victim's household, an older daughter in the process of purchasing a vehicle which is unidentified at time of report. A second daughter is 11 years old which denied the sexual encounters that her sister related to however appeared to be nervous and it is felt by the two RPs that the 11 year old daughter might also be involved with sexual encounters with the father.

It was reported that the victim's family will be moving from their residence in the extreme near future from the address of [redacted] Ave., however it was reported that they would be relocated in the City of Albany at an unknown single-family dwelling. Perhaps contact at the post office will reveal an address change for the Whitacre family.

The victim's mother is identified as [redacted] with a business address of [redacted], Oakland, Ca., phone number unknown at time of this recording.

The victim was hesitant to relate her sexual experiences with her father before making the two girlfriends swear to secrecy before relating to the incident. Apparently the victim is afraid that a divorce will occur within the family unit and gave every indication that the practice will continue very shortly and had been a recurring, frequent episode in their lives.

RO has made no contact with the Whitacre family.

Please see original report for information and details relating to [redacted], reporting to her friends that she had been sexually molested by her natural Father, Alfred. Investigation into this matter and interviews with the victim and her Mother, reveal this case to be a figment of the imagination of [redacted], therefore this case is reclassified as UNFOUNDED, with no further action contemplated.

On 7-24-83, Officer W. LEGGETT was dispatched to the [redacted] residence at [redacted] St. to speak with Ms. [redacted], whom wished to make a sexual Molestation report. Upon the arrival he learned that the above listed victim, [redacted], had been visiting with the [redacted] girl, [redacted] and another 11 year old, [redacted].

During the course of the visit, the three Girls went into a secret room in the [redacted] residence at which time they swore each other to secrecy and then told of their deepest darkest secrets.

During this encounter, [redacted] told the other two Girls that her Father "Does it to her" she continued by relating that this has occurred over the past two years, occurring for the first time on a camping trip to Lassen, when the rest of the family had gone on a hike while she and her Father stayed behind in camp. She stated that her Father disrobed and began rubbing his Penis all over her body.

She continued by stating that she has engaged in Sexual Intercourse and Oral copulation with her Father.

This case was referred to this officer for investigation, however at the time, this officer was off duty injured and did not return to work for several weeks, therefore no follow-up was done.

This officer then made contact with the Mother of the victim, [redacted] on 9-13-83 and requested that she come to the P.D. to talk about the offense. She agreed, arriving a short time later.

Upon the arrival of Ms. [REDACTED], this officer invited her into my office and there, explained the facts of the offense to her. Ms. [REDACTED], related that she did not believe any portion of the report, that although she and her Husband had not been getting along as of late, he was not the type of person to do such a thing. She continued that if an act of Sexual Intercourse had in fact occurred between her Husband and her Daughter, [REDACTED], that because of the very small stature of [REDACTED], there would have been physical damage and tearing.

Ms. [REDACTED] was at a loss to explain why [REDACTED] would tell such a story, nor where she would have gotten such an idea.

She was asked if [REDACTED], during either of the last two years of school at [REDACTED] School she had attended any of the "Childrens Rights" sessions that were offered in which as a part of the program, a caution is given to the children about "A bad Uncle" and the good and bad ways for people to touch. She stated that she believed that she had attended the session, however there had been no discussion.

She related that [REDACTED] likes attention and being the center of things. She further related that [REDACTED] has been seeing one of the School Counselors on a regular basis.

At this point, it was pointed out to Ms. [REDACTED] that I would have to talk to [REDACTED] and she readily agreed, requesting however she she did not want to be present. It was explained to her that I would talk to [REDACTED] at School in the presence of the Principal and the School Psychologist/Counselor, [REDACTED].

An appointment was made with Ms. [REDACTED] to interview [REDACTED] at School on 9-14-83.

On the above date, this officer proceeded to [REDACTED] School and there met with [REDACTED] and fully explained the reported offense. She stated that she had been dealing with the family for some time and that there were family problems, however not of this nature. She stated that she would get Kim out of class and bring her into her office.

[REDACTED] came in with [REDACTED] and introductions were made.

It was explained to [REDACTED] that I was a Police Officer and that my job was working with Kids. She was told that I had heard some stories about her and her friend, [REDACTED] and [REDACTED]. That they had been telling secrets:

At this point, [REDACTED] stated "There not true" I asked her what she meant by "There not true" and she stated that she had made up the story that she told about her Father.

I questioned █ as to why she would tell this type secret and she stated "I dont know". she was questioned several times about the incident and she would always answer the same. That she had made up the story for █'s benefit and for no' other reason. She was asked if she had taken the Child Rights class and she stated that she had. She was asked if she had thought about this when telling the story and she stated she had. It is unknown if this question put words into her mouth, however throughout the interview she maintained that the story was a fabrication. At this point she began to cry and so was allowee to return to class.

A discussion was held with Ms. █, and she stated that she felt that the girl was telling the truth. She stated that she has delt with her in the past and that she was capable of making up such a story without any thought as to the possible outcome.

This officer agrees that the story told by █ is in fact a fabrication and told only for the benefit of █.

This information was then relayed to the Mother who also concurs that the story was indeed a fabrication.

Under the circumstances, this reports is reclassified as UNFOUNDED with no further action.

criminal complaint filed against him. It appears that the most serious molestation claims are being made by [REDACTED] and [REDACTED]. Based upon the police reports and the transcript of the preliminary hearing, which we have also obtained, it appears that Steve Kabearly engaged in the viewing of pornographic films and acts of mutual masturbation with these two boys. It currently appears that these acts took place in his home and not during scouting events. The other allegations against him stemming from scouting events include inappropriate hugging of some of the boys, requests to have them undress and sleep with him after their tents or sleeping bags had been found to be wet (there is some question as to whether Mr. Kabearly intentionally created these situations), and the taking of photographs of the boys while nude. One of the photographs allegedly involved the fondling of a wooden penis, which allegedly belonged to Steve Kabearly. Mr. Kabearly is also depicted in the photograph. We have not yet had an opportunity to view these photographs.

Of particular note is a police investigation report from 1983 involving Karl Whitacre. Up until now, our information suggested that Mr. Whitacre was named as a defendant because he was the assistant scout master and possibly allowed the boys to "skinny dip" on scouting trips, and because he may have photographed some of the boys while they were naked. The Albany Police Department received a report that Mr. Whitacre had engaged in a sexual relationship with his youngest daughter when she was between the ages of 9 and 11. This report was investigated and the daughter stated that she had made up this story. The investigating officer concluded that there was no evidence of child abuse, based on the recantation of the daughter. It currently appears that neither the Boy Scouts nor its local council had knowledge of these allegations against Mr. Whitacre.

A summary of the testimony at the preliminary hearing may be helpful in understanding the claims being made in this case. Mr. Kabearly ultimately entered into a plea bargain as to several felony child abuse charges. The various allegations can be summarized as follows:

The incident involving [REDACTED] occurred in 1983 when he was in the sixth grade and a Cub Scout. His ^{brother} [REDACTED] joined Boy Scout Troop 22 (Steve Kabearly's troop) for a camping trip in the mountains near Placerville, California. His sleeping bag became wet for unknown reasons and he had to sleep inside the cabin. He testified that Steve Kabearly told him to take off his clothes so that they would

Subject of this report, [Redacted], a white female juvenile; 11 years old, confessed to [Redacted] and [Redacted] that she had been sexually active with her father for the past two years. This included intercourse and oral copulation. Her father's sexual advances started approx. two years prior on a camping trip and subsequently as a continuing problem. The victim was sworn to secrecy for fear of divorce of the victim's parents.

On 7-24-83 at approx 1245 hours the above RP/ [Redacted] landwired the Albany Police Dept requesting to speak with an officer regarding a possible sexual relationship between a 9-year old female juvenile and her natural father. RO met with Mrs. [Redacted] at her residence located at [Redacted] Ave., Berkeley, Ca. On arrival Mrs. [Redacted] explained to RO that her daughter was 11 years old, and with two of her playmates were sharing secrets at which time one of the playmates confessed to having a sexual relationship with her father for the last two years which included intercourse. Mrs. [Redacted]'s daughter was present during the time and was introduced to RO and the above [Redacted] Lee.

[Redacted] who is 11 years old stated that several days prior she was introduced to the victim who was verbally identified as [Redacted], 11 years old, by a mutual friend who was identified as the above [Redacted] of [Redacted] Ave., Albany. Ms [Redacted] stated she has known [Redacted] for approx. two years, subsequently developing a friendship. Apparently [Redacted] had known the victim for approx. two years and had just introduced the victim to [Redacted] several days prior.

Ms [Redacted] continued explaining that she, [Redacted] and the victim [Redacted] approx. three days prior were over at [Redacted]'s residence. [Redacted] stated that all three girls were in a secret room inside [Redacted]'s residence. The secret room is accessible only by a small crawlthrough doorway located in the bathroom which leads into a larger room of the approximate size of a kitchen nook.

Apparently all three juveniles entered the secret room and were sworn to secrecy, then began telling their bad experiences. At that location the victim first listened to [Redacted] and [Redacted] confess their closely guarded secrets. Both [Redacted] and [Redacted] had asked the victim to relate her worst secret and the victim, still a little hesitant, again made [Redacted] and [Redacted] swear to secrecy because if anyone knew of the secret the parents would get a divorce and they are apparently in vericable combat.

to secrecy. After a brief discussion regarding "good and bad secrets" [redacted] stated that the victim first advised her of the sexual advancements approx. one year prior pertaining to the vacation at Lassen. [redacted] was told by the victim that she has intercourse with her father and also engages in oral copulation with some frequency.

[redacted]' mother and father who were both present during the interview with their daughter, at which time [redacted]' mother stated that approx. one year prior the daughter had told her that the victim's father was having a sexual relationship with his daughter. However Mrs. [redacted] did not believe the daughter and failed to report the incident to the proper authorities.

In a limited investigation it was found that the victim's parents are both employed. Her mother is employed as an attorney and the father works at [redacted]. The victim made both RPs swear to secrecy regarding the sexual encounters with her father for fear of divorce, for her parents were not getting along now and arguing frequently.

Apparently there are three daughters in the victim's household, an older daughter in the process of purchasing a vehicle which is unidentified at time of report. A second daughter is 11 years old which denied the sexual encounters that her sister related to however appeared to be nervous and it is felt by the two RPs that the 11 year old daughter might also be involved with sexual encounters with the father.

It was reported that the victim's family will be moving from their residence in the extreme near future from the address of [redacted], however it was reported that they would be relocated in the City of Albany at an unknown single-family dwelling. Perhaps contact at the post office will reveal an address change for the Whitacre family.

The victim's mother is identified as [redacted] with a business address of [redacted], Oakland, Ca., phone number unknown at time of this recording.

The victim was hesitant to relate her sexual experiences with her father before making the two girlfriends swear to secrecy before relating to the incident. Apparently the victim is afraid that a divorce will occur within the family unit and gave every indication that the practice will continue very shortly and had been a recurring, frequent episode in their lives.

RO has made no contact with the Whitacre family.
