Please note the attached news article providing information on the sentencing of Andres Quintano. Apparently Quintano was involved at one time with Robert Izzo. An ineligible volunteer file has already been established on Robert Izzo.

The newspaper article advises that Quintano told police that he became friendly with Izzo in 1982 when both were leaders at a Boy Scout outing. The newspaper article also indicates that Quintano should be eligible for parole in a year. Because Andres Quintano was apparently a Scout leader at one time and will be in jail for only a short period of time, it is my recommendation that he be placed in the ineligible volunteer file.

# Man Sentenced in Sex Abuse Case

## Jail term for ex-bus driver who aided Izzo

A former school bus driver who sexually abused a 10-year-old girl and said he operated a school bus while Robert Izzo sodomized a kindergarten boy was sentenced yesterday to the maximum term of 2 1/4 to 7 years in prison.

Anders Quintano, 33, of 229 Cushing Ave., Williston Park, pleaded guilty last fall to first-degree sexual abuse and criminal facilitation. He was sentenced in Mineola before County Court Judge Jack Mackston, who also ordered him to pay restitution of more than \$2,000 to the girl's family for psychological counseling.

Mackston imposed the maximum penalty despite pleas by defense lawyer Eugene Cordaro and Quintano's admissions of guilt.

"I know I'm wrong and I want to get help," Quintano told the judge, his voice quivering. "But at the same time I want to be able to go home to my wife in as short a time as possible and get on with this business of supporting my wife."

Quintano was arrested on Nov. 15, 1989, and charged with first-degree sodomy and first-degree sexual abuse. In a plea bargain, he later admitted to fondling a 10-year-old girl in his Williston Park home on March 16, 1987. He also said he drove a school bus so that Robert Izzo could molest a kindergarten boy

in the back of the bus.

Izzo, 41, was convicted last week on 35 counts of sexually abusing three former Boy Scouts and a fourth boy whose family he befriended. He is scheduled for sentencing April 2. Izzo also is facing trial on 143 counts of sexual abuse in connection with the sexual abuse of 16 kindergarten children who rode on his school bus. He has denied all charges.

Quintano told police that he became friendly with Izzo in 1982 when both were leaders at a Boy Scout outing at the Livingston Manor summer camp upstate.

Quintano began working as a school bus driver for Harran Transportation Co. of Babylon in 1985 and helped Izzo get a job with the company in 1986.

The incident involving Izzo occurred between September, 1987, and March, 1988, according to Edward Grilli, a spokesman for the Nassau district attorney's office.

The sexual abuse incident was not reported to police by the victim's family until the Izzo case became public, Grilli said.

Quintano has been in jail since his arrest and should be eligible for parole in a year, Cordaro said. The district attorney's office has declined to say whether Quintano will be called to testify against Izzo.

# Man Admits He Drove Bus During Assault on Child

In what is expected to be key evidence in the prosecution of Robert Izzo, a former school bus driver yesterday admitted he drove while Izzo sodomized a kindergarten boy on the school bus.

Anders L. Quintano, 32, of East Williston made the admission in Nassau County court in response to questions from Assistant District Attorney Maureen Riordan, who is prosecuting the Izzo case. Izzo has been charged with 178 counts of rape, sodomy, sexual abuse and endangering the welfare of a child.

Quintano pleaded guilty to criminal facilitation for driving the bus while Izzo sodomized the boy. He also pleaded guilty to first-degree sex abuse in an unrelated case in which he admitted fondling a 10-year-old girl, the daughter of a family friend, in March, 1987.

County Court Judge Marvin Goodman scheduled sentencing for Dec. 6 and promised Quintano that he would not receive more than 2 1/2 to 7 years, the maximum penalty for first-degree sex abuse.

Quintano's lawyer, Eugene Cordaro, said in an interview yesterday that his client pleaded guilty to the top count because he "wanted to get it over with."

Izzo is being held on \$750,000 bail in connection with the alleged sexual abuse of 21 children, including 16 kindergartners. Quintano's name came up during the investigation of Izzo.

Dear Paul:

Enclosed is the "Ineligible Volunteer Record Sheet" with all the information we have on Anders "Andy" Quintano.


Andy resided in Florida for an extended period of time, the exact location is not known to us. In a letter dated September 15, 1989, (enclosed) and with a subsequent conversation with the writer, Donald Myers, we learned that Andy had returned to Long Island.

When this became known to me I immediately notified the Sex Crime Unit of the Nassau County Police Department. They subsequently started an investigation and on October 23, 1989 Andy was arrested on a charge of sex abuse, first degree. He is still in jail as a result of this charge and I further understand that an investigation of his activities is still continuing.

For your information, Mr. Quintano was a friend of Robert Izzo, an individual who has had over 147 sex abuse charges filed against him in 1989 by the Nassau County District Attorney (see your files). It is the opinion of the Sex Crime Unit of Nassau County Police Department that the activities of Robert Izzo and Andy Quintano are connected.

As usual, I will keep you informed as more information is made available.

This letter has been written in our minds for quite some time and up until now we could not bring ourselves to put into words the pain we have in our hearts.

However, due to the recent publicity (and recognition of one of those accused of child abuse in the newspaper as being a friend of the man we accuse of sexual assault), we feel it necessary to notify Nassau County Council, BSA, of a former scout leader from our area who molested our daughter.

1987—Anders (Andy) Quintano was 29 years old—active in Little League, Boy Scouts, Girl Scouts, a summer camp counselor, and a school bus driver by trade—and our daughter was 10 when he sexually abused her. His access to [REDACTED] was easy (her Little League coach, Assistant Scoutmaster to [REDACTED] who is Scoutmaster of Troop 201, the son of our son's Godparents; he even referred to us as "aunt" and "uncle."). In fact he molested our daughter in our own home.

We found out about the incident when the school called to question us regarding her school performance. She was showing signs of being disturbed, preoccupied and not performing as well as she was capable of. [REDACTED] had kept the incident to herself—with all the textbook symptoms and characteristics of a child who was molested. The school tried to notify the authorities and was told that the proper procedure was to notify the police and have an arrest made. Due to the "family" situation, we chose not to publicize the incident but handle it ourselves.

When we confronted Andy, he did not deny it; he promised to seek professional psychiatric counseling for his problem which he fully acknowledged. He then moved to Florida, married a woman with a little girl (whom we felt deeply sorry for) and has since become father to a son.

[REDACTED] was in therapy for over a year. In fact, it was necessary for [REDACTED] and I to attend counseling for another year with and without her to help with the situation as it had become since the abuse.

After viewing the videotape on child abuse presented by Nassau County Council and speaking with Steven Humphrey, County Executive, Shelter Rock District, [REDACTED] was told we were required to provide a letter about the incident to prevent Andy's future involvement in the Boy Scout program—anywhere in the U.S.

Please advise us as to whether Nassau County Council, BSA, will pursue this matter further or whether we will have to proceed on our own. We would appreciate your notifying us by the end of September at which time we intend to contact National of the circumstances upon which our request for their intervention is based. Thank you.
