This letter is in response to a request from Harold Fieszal, asking me to inform you of my involvement in the Chris Blane incident that occurred during the 1981 National Scout Jamboree.

First, I was not directly involved with Chris Blane or the person that cared for him during the jamboree. I do not know either of those people. My involvement was with a young man named [redacted] that was an employee of [redacted]. We had contracted [redacted] to provide janitorial service for certain latrine and shower facilities at the jamboree.


Bob Bradley and Glen Helberg informed me that [redacted] had been accosted by the person that was caring for a young Scout that was paraplegic. Bob Bradley is a professional on my staff and was responsible for sanitation facilities at the jamboree. Glen Helberg had been recruited by Bob Bradley to monitor the janitorial contract. Glen Helberg also happens to be a professional employed by the Santa Clara County Council, San Jose, California. Glen and I then went to the jamboree headquarters building where [redacted] was assigned to work at cleaning the restrooms and showers. I asked [redacted] to tell me his story, which he did. We then went upstairs and found T. J. Van Houten. T. J. was the jamboree administrator. I asked [redacted] to again tell his story to T. J., which he did. T. J. decided that the director of operations should be informed; so, we found Jad Asfeld and advised him of the story. Jad was the volunteer chairman of operations. Jad indicated that we should have a written statement prepared by [redacted], witnessed by Glen Helberg and myself, which we did. A copy of that statement is attached. I turned the statement over to Jad Asfeld and told [redacted] to go back to work. I told him that we would advise him later if

After that, I did not receive any further information during the jamboree. I was not informed of any action taken as a result of this statement received from [REDACTED]

Friday July 31st

I [redacted] my [redacted] morning in the rest rooms in the school house cleaning them up. As I was working a man came in with a paraplegic in a wheel chair. After he had bathed the paraplegic he asked me would I help him for a minute. He asked me to pick the boy up while he slid his pants up, Afterwards I helped him up the steps and out to his van. We the pulled for several minutes, and then I said "it was nice. talkin' to ya but I've got to get back to work so then I left."

Saturday Aug. 1st

While on my lunch break he pulled up (with out the paraplegic) and said "if look hot out there, if you want you can eat in here if a lot cooler" and since it was hot I said okay. I thought he was just returning a favor. While sitting in the van eating we started to talk he asked me "if I ever sprayed around" I thought he was talking about girls so I replied "yes, all the time" and then he asked me "if I sprayed around with guns" I said "No I've never tried it and I don't want to."

Then he said "well I haven't had a woman
in ten (10) days and I'm looking for
someone to lay down with" I said "So
but I can't help you" and started to
get out, but before I got out he said
"I would like to fool around with you, but
I has to be when the perpoxide is in
crowd" well as he was saying this I
was in the process of getting ^{out} he then said
he would be back for a shower at 3:00
and he would see me then:

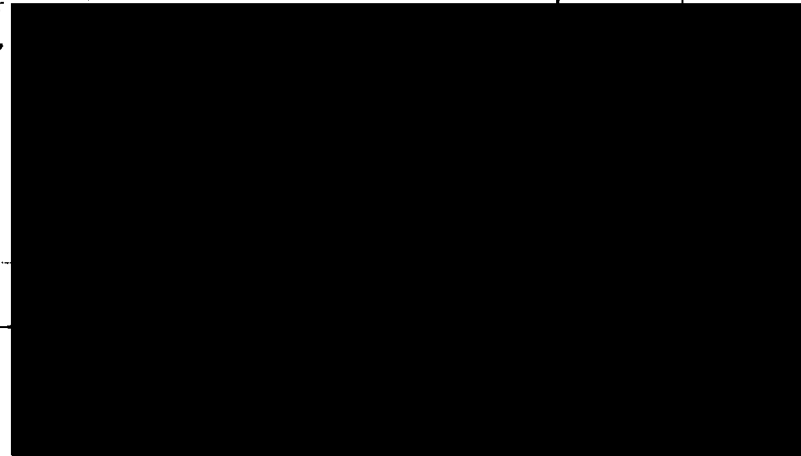

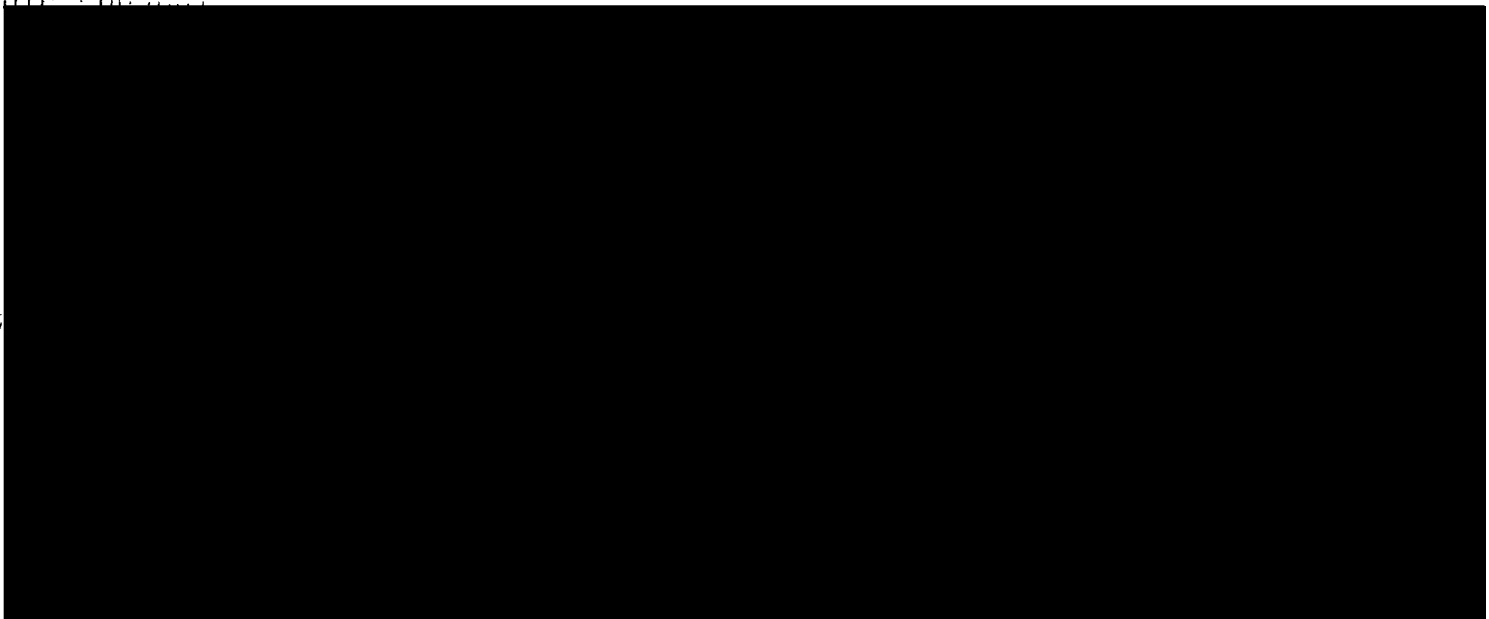
