Scout's holiday fraud

A JB scout, who came to Australia for a holiday after seeing Crocodile Dundee, spent more than \$3000 with a forged credit card, the Melbourne Magistrates' Court was told yesterday.

Dion Michael O'Bannon, 27, gave his temporary address as Hope St, Glen Iris, and pleaded guilty to 82 counts of obtaining property by deception.

Mr David McSteen, for O'Bannon, said unlike the film, O'Bannon had bitten off more than he could chew.

Sen Detective Ian McKinnley, of the fraud squad, told the court the

enabled him to leave the US under a cloud. But he would finally be caught because all his ports were being watched. He said O'Bannon would want to return to Australia because of the relationships he had made, without a country of residence.

Chief Magistrate Mr John Dugan said O'Bannon's plea of guilty was an "exhibition of remorse". Mr Dugan said O'Bannon was "a man of tender years" and he accepted the fact O'Bannon was prompted to commit these offences by the means of a scam.

He ordered O'Bannon to pay \$1000 to the police and put him on a \$1000 twelve-month good behavior bond.

'Dundee' fan used altered credit card

offences occurred between September 25 and November 23, when O'Bannon and a co-offender fraudulently altered a Visa Card issued by the Chase Manhattan bank in the US.

He said the credit card was used to buy petrol, photographic equipment and food. Sen-Det McKinnley said the co-offender who investigated the offences had not been caught.

Mr McSteen said the co-offender would face twice as many offences as O'Bannon because he prompted the deception. Mr McSteen said the co-offender's cunning

Lift medical advertising bans — report
