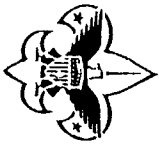


SUBJECT: Ineligible volunteer - Brian Drummond - former

The attached documents outline the profile type behavior and the reported attempted molestation behavior.

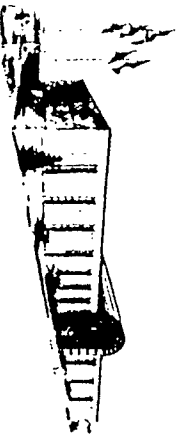


Dear Ben:

Dick Daffner and I met separately with [REDACTED] this past weekend to discuss with them allegations they had made regarding Brian Drummond. After we met with each of the boys, Dick and I concluded that there was more than sufficient information developed to warrant a more thorough investigation. We met with our Troop Committee Chairman, Jim Simmons, and reviewed with him our impressions. Jim concurred that further action is warranted and informed Brian that he was relieved of his leadership position until these matters could be resolved. Dick delivered a letter to Brian on May 29 confirming this. A copy of that letter is attached.

Attached to my letter is a summary of the allegations made by each of the boys. I am also enclosing my original notes (I have retained a photocopy).

Please let me know how you wish to proceed.

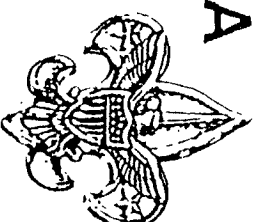

Dear Brian:

This is to inform you that serious allegations of personal misconduct have been brought against you by several boys in the Troop. According to the standard operating procedure of the Boy Scouts of America and Allegheny Trails Council, we have been directed to conduct a preliminary investigation at the troop level to determine whether these allegations have sufficient basis to either close the matter or to proceed with a more formal investigation at the Council level.

After a preliminary investigation at the troop level, which included extensive interviews of the several boys involved, by Mike Dantel and myself, we have concluded, with concurrence of Jim Simmons, Troop Committee Chairman, that there is sufficient cause to pursue a more thorough investigation at the Council level.

Accordingly, and in compliance with Council and BSA rules we are taking the following actions:

1. A formal report is being made to Council for their disposition.
2. Effective immediately, we are relieving you of your leadership position with Troop 28 until such time as these matters can be totally resolved in your favor or the allegations can be substantiated against you.
3. We are directing you not to initiate any contact with the youth members of Troop 28 or to attend troop functions, again until such time as this matter is resolved. This restriction includes meetings, camp-outs, and summer camp.
4. Since some of the allegations may have legal consequences, you are advised to seek legal counsel.

I am sorry that after a long and mostly productive period with Troop 28 these matters surfaced. I am doubly sorry to have to conduct a part of this investigation of a friend.

Present were: Richard H. Daffner, M.D. and R. Michael Daniel.

Several Scouts took a trip with Brian to King's Mountain (apparently this is a cabin which is owned by the father of one of the boys, [REDACTED]). There were several Scouts plus Brian. Several of the Scouts brought porno flicks. Brian told the Scouts that they could do whatever they wanted to, including watching the movies. Brian slept in a room with [REDACTED]. They slept in the same bed under the sheets. Everyone had taken sleeping bags, but Brian and [REDACTED] did not use them. Brian told us not to say anything about the movies to anyone and that if we did, he would get us.

When I first joined the Scouts we went on a campout. I went into Brian's tent and he and several other boys took off all of my clothes and put them in a tree. Later that same weekend Brian gave me a back rub and during the rub tried to unbutton my pants. I made him stop. I never said anything about it because I was scared people would think something was wrong with me.

Last summer we went to Westmoreland County for survival games. You rent a gun that shoots paint pellets. We divided into teams and our team beat Brian's team pretty badly. Brian got real mad and attacked me. He tried to shoot me at very close range with one of the guns. People had to pull us apart.

A week ago at OA camp I saw Brian giving [REDACTED] a back rub. He must have rubbed his back for almost an hour. I heard he was also giving back rubs to [REDACTED] and [REDACTED].

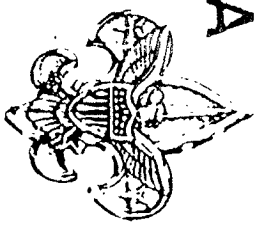

In October of 1988 several of us went to King's Mountain. Brian was the only adult present. We took a VCR and several adult movies. The boys obtained the movies, not Brian. Brian let us watch them. Brian and [REDACTED] spent a lot of time together in their bedroom. They usually kept the door closed. It was a room with one bed. They slept under the sheets. I saw them in the bed and they had no shirts on. I walked into the room later and saw Brian giving a back massage to [REDACTED]. He was rubbing him with baby oil.

At the beginning of winter, 1988 Brian, [REDACTED] and I went for a hike on the Laurel Trail. We spent the night on the trail. Brian started a wrestling match when we had set up camp. I'm not sure whether it was Brian or [REDACTED], but one of them tried to grab [REDACTED] penis. Brian pulled [REDACTED] pants down and tried to put his finger up [REDACTED] rectum. They then tried to pull me out of my sleeping bag. They took my shirt off and poured Pepsi on my chest. [REDACTED] tried to lick it off. I didn't say anything because I assumed they were fooling around. I knew something was wrong, but I wasn't sure what to do.

Two years ago in the fall, we went on a rappelling trip. I became ill with what was later diagnosed as strep throat. My limp nodes were swollen. Brian told me to get in my sleeping bag and sleep. Around dinner time he came to check on me. He felt the nodes in my neck and then opened my sleeping bag and felt around the nodes in my groin and crotch area.

I saw the incident with my brother, [REDACTED] and Brian at the survival games. Brian and [REDACTED] got real mad at each other. Brian wrestled [REDACTED] to the ground and held him to the ground and held the gun next to [REDACTED] body and fired the gun.

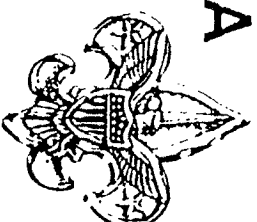

Dear Ben:

This is to inform you that we have completed a preliminary investigation at the troop level of allegations of misconduct brought by several of the boys of the troop against Brian Drummond, Assistant Scoutmaster. As a result of this investigation we have concluded that Brian has engaged in behavior inconsistent with that expected of an adult leader and that he has participated in, or encouraged, activities in violation of established rules of conduct for members of the Boy Scouts of America. In doing so, he has abrogated the acceptable standard of adult accountability for his leadership position. In addition, two scouts have made serious allegations of attempted molestation which warrant further investigation by a higher authority.

Accordingly, we have taken the following actions:

1. Mr. Drummond has been relieved of his leadership position with Troop 28 until such time as the allegations can be proven or disproven.
2. Mr. Drummond has been instructed not to initiate any contact with any youth members of Troop 28.
3. He has been advised of the seriousness of these allegations and has been informed of the desirability to retain legal counsel.
4. A full report of the allegations and the interviews with the boys involved will be made to you by Mike Daniel.

As you can imagine, I am very upset that we have to confront this matter. However, I am also cognizant that there is a greater awareness of these problems, and we must face them as they arise.

I would be happy to meet with you at any time you deem mutually convenient for further discussion on the disposition of this matter.

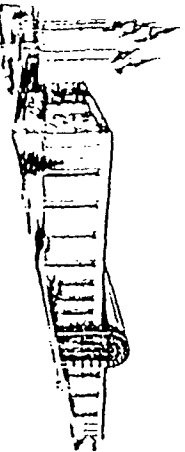
