

Dear Howard:

Following up on your letter of July 18th relative to Mr. Bruce C. Smith, now placed on confidential file, formerly registered as a Scoutmaster of Troop 644, Alta Loma, California, The following particulars were obtained from the district attorney's office which should suffice for your file.

The original complaint against Mr. Smith was four counts, two of penal code #288, child molesting under age of 14, and two counts of penal code #288A, oral copulation of a child under 14. Mr. Smith decided to plead not guilty therefore the district attorney's office filed additional charges of 15 other counts for the same code violations. There were 9 additional victims involved.

He ultimately pleaded guilty to two counts, 1 each of penal code #288 and #288A. The case has since been referred to Superior Court for probation. He has been examined by two psychiatrists who find him MDSO (mentally disordered sex offender). Superior Court will review his case, if they find him MDSA he will be sent to prison or a corrective institution, if not he will be placed on probation.


