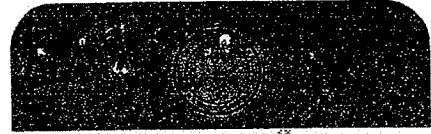

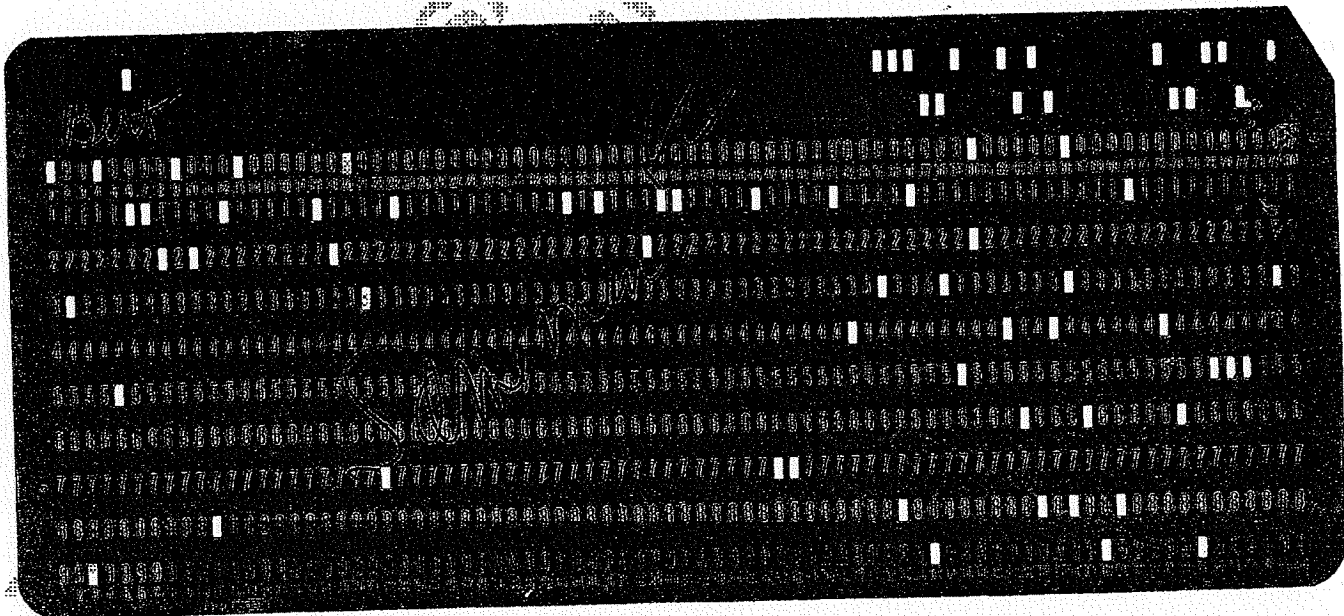

I am writing to you with regard to the correspondence originated by Mr. William R. Dukelow, Field Director of our Council, pertaining to Mr. Charlie Dohm.

We have had the opportunity to check more thoroughly on this man. Having talked with our District Executive Kermit Stanley and the former District Executive, Bill Kenny, we would recommend that this man be placed in the Confidential File for the following reasons:

- 1) He is mentally retarded, with an I.Q. of less than 80.
- 2) He is emotionally unstable; plus records of Alameda County indicate he has been picked up on several occasions for reckless actions.
- 3) He has acquired an Alameda County Sheriff's Office record for molesting boys and recently undertook surgery, at his request, in lieu of a jail sentence.

For your information his correct name is Charles Bert Dohm; home address, 317 East 17th Street, Oakland, California; 42 years of age; Caucasian; unmarried; religious preference, Catholic; grammar school education; telephone, GL 1-6589. He was last registered as Assistant Scoutmaster of Troop 201, November 1964 date of expiration. He has not reregistered, and we have refused to accept his registration at this office in his current efforts.

Would you please forward appropriate forms, which I will arrange to have completed.
