Admits to

Sex Crimes

ATLANTIC CITY — A former Boy Scout troop leader pleaded guilty in Superior Court here Wednesday to sexually assaulting at least 13 youngsters over a two-year period. Charles Paul Geiger, 3rd, 47, of Cardiff was a sixth-grade teacher at Davenport School in Egg Harbor Township, a Little League coach and scoutmaster at the time of his April arrest. All of his victims were from his scout troop, Geiger told Steven P. Perskie, Jr.

Geiger pleaded guilty to two counts of sexual assault. The first count alleges that he molested numerous children on various dates in 1985. The second count alleges different children were assaulted between January 1986 and April 17, 1987, when he was arrested.

When asked to recount what he did that made him guilty of the crime, Geiger replied, "I touched the person's private parts."

He said he wasn't sure of the number of boys involved but added "the wording in the accusation) was probably accurate. Ninety."

"Approximately 13 individuals," he said. Most of the boys were between 14 and 16 years old, Geiger said, but one or two in each count, were under 13.

His purpose in committing the crimes, he said, was for sexual gratification.

Although sexual touching is considered sexual contact, Geiger was charged with sexual assault use under the law. If a victim is 13 or younger, and the defendant is at least four years older than the victim, a sexual contact charge is upgraded to the more serious crime of sexual assault.

Geiger faces a maximum 20-year sentence, of which he could be ordered to serve as much as 10 years before he becomes eligible for parole.

Atlantic County Prosecutor Jeffrey S. Blitz said there was no sentence bargaining with the defendant. Consequently, Geiger's sentence will be left entirely in Perskie's discretion.

Geiger will not be sentenced if he is evaluated by doctors at the Adult Diagnostic and Treatment Center in Avenal to determine if he is a "compulsive and repetitive sexual offender." If he is diagnosed as such, Perskie will have the option of sending Geiger to the center for treatment instead of prison.

July 4 Rally Set By Blacks

ATLANTIC CITY — A new coalition of black leaders, saying the city's black community is a victim of racism by the media and casino industry, will hold a Black Unity Demonstration in Columbus Park on July 4.

Clinton Walden, vice president of the new Citizens for Action committee, charged on Wednesday that the Atlantic City Casino Association has ignored the demands of the two local branches of the NAACP for the past two years.

Walden said those demands include hiring more blacks and Hispanics for executive positions, better compliance with requirements for minority business set-aside requirements and aggressive enactment of affirmative action plans.

"Up to this point, no movement nor positive strides have been made or attempted," said Walden, a city codes enforcement officer and direct action coordinator of the Mainland branch of the NAACP. The plans were announced at a City Hall press conference.

The rally will start at 10 a.m. in the park at Arctic and Missouri avenues. Walden said the list of speakers hasn't been set.

Walden said the rally also will be held to protest what he called "a systematic scandal to lynch and discredit black leadership in this city" by "The Press and other media outlets."

"The Press is a major problem. We're always looked at in a nega-

After Perskie accepted Geiger's guilty plea, Blitz moved to have the \$40,000 bail Geiger posted revoked. He said Geiger no longer enjoys the presumption of innocence and should be jailed.

"He is a confessed and convicted rapist," Blitz said. "He is a convicted felon, in all likelihood, substantial incarceration under the law," Blitz said.

"Considering the nature of the crime, the likelihood of flight and his propensity to assault young boys," Blitz said Geiger should not be allowed to remain free until he is sentenced.

D. William Subin, Geiger's attorney, said since his client's arrest, Geiger has fully cooperated with authorities. Subin said it is very likely Geiger would free the jurisdiction, since he has been an area resident for over 40 years and he has family in the area. "He is married and his wife is here in court with him," Subin said.

"Since he has been out on bail at my advice, he has sought psychiatric counseling," Subin said. The attorney also told the court that Geiger "has not had even casual contact" with any children.

"He has given up teaching, coaching and scouting," said Subin, noting that all of the incidents arose from Geiger's association with the Boy Scouts.

Subin argued that if Geiger remained free, he could continue his counseling.

"Incarceration in the county jail is not designed for treatment of this kind," Subin said.

Perskie said the Legislature has designated the offense to which Geiger pleaded a second-degree crime, which "carries a presumption of incarceration for a lengthy period of time."

"I don't know anything about Mr. Geiger at this time, but I am constrained to acknowledge the nature and seriousness of the crime of which he now stands convicted," Perskie said.

"I am satisfied the prosecutor's motion should be granted. For the protection of the community and in the interests of justice bail will be revoked," Perskie said.

At the time of Geiger's arrest, Sgt. Harold Kauffman, the senior investigator with the Child Abuse Unit of the Atlantic County Prosecutor's Office, said the assaults "took place on Boy Scout outings and camp-outs at various locations."

Scout Chief Charged in Sex Crimes

EGG HARBOR TOWNSHIP — Police arrested a 47-year-old schoolteacher and Boy Scout leader Friday afternoon and charged him with sexual assault and child abuse stemming from incidents alleged to have happened on scouting trips.

Charles "Chuck" Paul Geiger III, of the Kie-Tro Apartments, was taken into custody by authorities at his residence, according to Assistant Atlantic County Pro-

secutor Dean Wycks. Geiger, formerly of Ventnor, is a sixth-grade teacher at the Davenport Elementary School, a local little league coach, and a leader for Boy Scout Troop 25, Wycks said. He said all the victims were members of Geiger's Boy Scout troop.

Egg Harbor Township School Superintendent Frederick Nickles III, said he has suspended Geiger "indefinitely."

The warrants for which the suspect was arrested allege also worked at Holy Spirit High School in Abscon, Nickles said. "Before hitting him, we did a full background check," said Nickles. "We found nothing in the interview process that was questionable as far as his character was concerned.

"However, upon learning of the situation today, as superintendent of schools, I have suspended him indefinitely," Nickles said.

"At no time have we ever had any complaints issued nor has there been anything to indicate there was anything of this nature going on in the school setting," Nickles said.

Phillip Geiger said, "There has never been anyone who has expressed concern regarding any aspect of his activities with youth."

"These charges come as a surprise," he said. "He's still innocent until proven guilty. They are just charges at the moment and I'm sure they'll be further investigated by police and the Prosecutor's Office."

Kaufman said. Digerolamo requested his assistance because of the number of youngsters in the scouting program who had to be interviewed, Kaufman said. Local police Detective John DeAngelis was called since the investigation was being conducted in Egg Harbor Township, he said.

Phillip Geiger, president of the Atlantic Area Council of Boy Scouts, said after being contacted at home by The Press that he was unaware of Charles Geiger's arrest or the ongoing police investigation. Phillip Geiger is not related to the suspect.

"To the best of my knowledge, he's always seemed to be well-respected by everyone," Phillip Geiger said. "No complaints have been issued about him to the scouting program nor has there been any correspondence or accusations."

The investigation into Geiger began after state police Trooper Rocco Digerolamo received a complaint last week from a 12-year-old youth and his mother.


