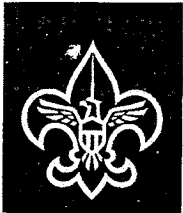

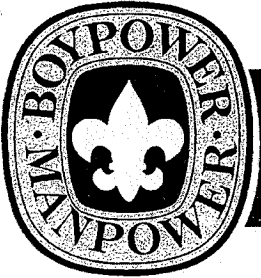

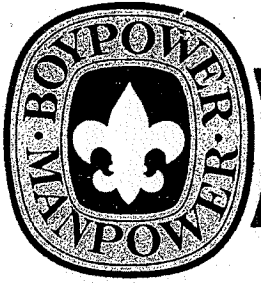

We finally have the information you requested regarding the updated confidential information on the above man. You had requested the information in August.

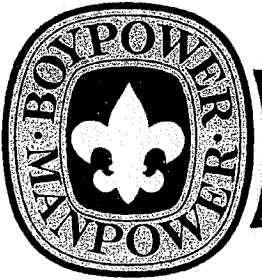

The situation was not brought to our attention until the following month, November, 1967. At that time we deleted his name as a registered Scouter in Troop 73 from our records and put him on the file to prevent his future reregistration, but as is usual in cases of this type, beyond advising you that we were putting him on the file, we did not then, nor do we now, recommend any action to take his registration certificate away from him. You are absolutely right, we open ourselves up to legal entanglements when we take action of this type. So, your Buffalo experience stands you in good stead.

Do nothing, except do not under any circumstances encourage this individual in any manner and if you should happen to know some of the key people in Troop 73, you might quietly indicate to them that there is a problem in connection with him and that National Council has advised you that it will not accept any application for reregistration by Wall.

The reason I wrote you as I recently did is because back in November of 1967 after rather considerable correspondence with George Darlington, I got a note back from him which said "He is still here-Going strong. Wonder if there are 2 Charles Walls?". Then this April I received additional information which prompted me to write you on the 22nd. I wanted you to know that he shouldn't be "going strong" and that there are not 2 Charles Walls, and that you should be on the alert against any activities on his part and that you and we should and will refuse his reregistration.


He is currently registered as a Committeeman with Troop 73 in Hyde Park.
