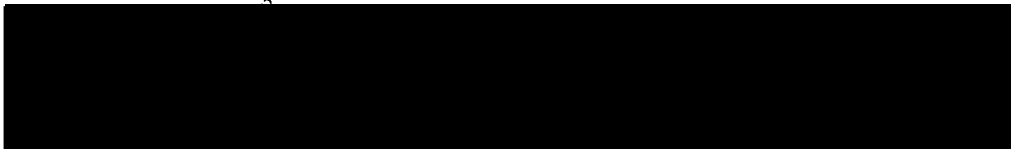

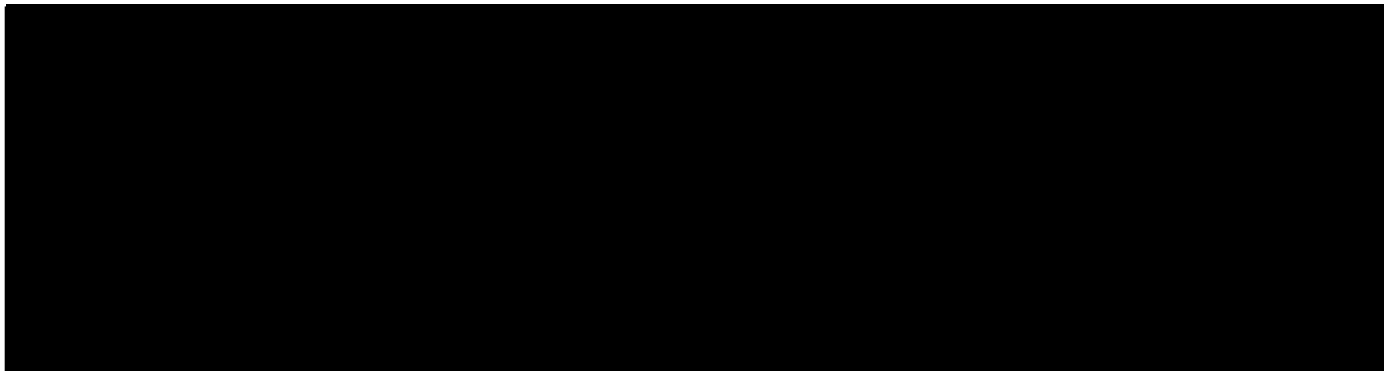

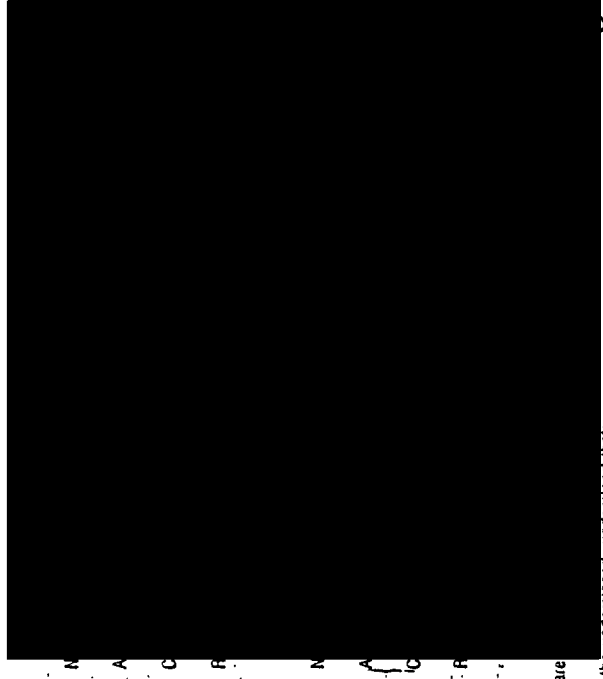

This is to advise you that Mr. Daniel Aviles discontinued his services from Pack 196 as Den Leader on March 31, 1989.

It was brought to our attention that Mr. Aviles had separated from his [redacted] last year. [redacted] was informed through someone in the community of Cypress Hills that her husband (Danny Aviles) was involved in BSA Pack 196 of the Rainbow District. As soon as [redacted] heard of her husband's involvement with boys she decided to contact Providencia De Jesus-Colon (a committee member of Pack and Troop 196). [redacted] stated to Mrs. Colon that, "he is not mentally prepared to work with youth because he had molested (sexually) [redacted] for a number of years until the boy had finally spoken up". To further confirm this allegation [redacted] provided the name and address of her Pastor Carmelo Rodriguez, Church name is [redacted] Brooklyn, telephone number [redacted]

I called Pastor Rodriguez and spoke to him personally. Pastor Rodriguez is very well aware of Mr. Aviles situation and stated that, "Mr. Aviles should not be permitted around children for their own safety".
