Attached is a letter from the Illinois Department of Children and Family Services indicating that Daniel W. Johnson has been "Indicated" on the allegation of Sexual Exploitation.

The details as I know them are:

At a troop meeting in late May, 1988, Dan took two boys to his home, allegedly to pick up some camping equipment for an upcoming campout. Once they were in his apartment, Dan closed the shades, put a pornographic tape on the VCR and left the room. Dan reappeared in a few minutes at which time he allegedly exposed himself to the boys and displayed a T-Shirt on which he had either urinated or ejaculated. The boys expressed that they would prefer to return to the troop meeting, which they did. This was the first troop meeting for both boys since transferring from Webelos.

As far as can be determined there was no physical contact between Dan and the boys at any time.

We have already sent a copy of Johnson's signature with the original information.


