In August of '86 he was arrested and pleaded guilty of sexual abuse of a 13 year old boy. (Copy of convictions and news clipping enclosed.) He had no affiliations with Scouting at this time nor had any in the previous 10 months.

I strongly recommend that Daniel W. VanLuven should <u>never</u> be allowed to affiliate with the Boy Scout Movement now or any time in the future.




