

# Man jailed on sex charges

A Laguna Vista man has been charged with sexually assaulting two children.

David P. Lowry, 41, of 113 Buena Vista Ct., was arrested Tuesday, June 20 in Orange County, Calif. on a sexual assault warrant out of Hood County, said Lt. Carole Stewart of the Hood County Sheriff's Department.

Lowry, an engineer at Comanche Peak nuclear plant, was at a seminar in California when arrested, Stewart said.

Lowry, who was charged with five counts of sexual assault of a child under 14, allegedly attacked

one of the children on May 20 and another on June 17, stated Stewart.

Lowry waived extradition and will transported to Hood County on

the charges, she added.

Lowry was being held in California at presstime on a \$50,000 bond, Stewart said.


Dear Dave,



Dear David:

We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.
