# Pornography defendant held in molestation

A former participant in the Big Brother program, already charged in connection with a child-pornography ring, is scheduled to be arraigned today on charges of molesting an 11-year-old Laguna Hills boy with whom he had been paired.

David Robert Negrette, 26, was arrested Monday in Los Angeles when he appeared in court in the child-pornography case. Huntington Beach police had been looking for him without success, Lt. Ed McErlain said.

Negrette, of Westminster, faces four counts of lewd acts with a child and one count of crimes against children.

According to an investigative report filed in support of the arrest warrant, the alleged molestation

came to light after Negrette's arrest in the child-porn case.

In that case, Negrette and three other men — one a former priest — allegedly ran a child-pornography operation that recruited Mexican boys to perform sex before video cameras in Ensenada, Mexico. Negrette allegedly appeared in the films. Three of the defendants, including Negrette, are scheduled for trial in Los Angeles on Oct. 20.

Several Orange County residents knew Negrette from his involvement with three Boy Scout troops — Nos. 247 and 1405 in Huntington Beach and No. 123 in Santa Ana. They called authorities, concerned that Negrette might have involved Scouts in the child-porn ring. Callers also told investigators that Negrette was involved in Big Brothers-Big Sisters.

Big Brothers told Huntington Beach police that Negrette had been dismissed in July 1986, after his "little brother" told his mother that Negrette had shown him sexually explicit pictures and made a "pass" at him, according to the report. The "little brother" added that Negrette had tied him down and exposed his genitals to the boy.

Big Brothers referred the matter to the county Child Abuse Registry, which contacted police in Huntington Beach, where Negrette then lived.

At the time, a Huntington Beach detective warned Negrette not to have further contact with the boy, but no formal report was taken and no investigation was done, according to the report filed with the warrant.

When another detective, Chuck Thomas, re-interviewed the boy in May, he said he had been molested by Negrette.

The boy, now 15, said he had not told anyone the full story because Negrette threatened to kill the boy's mother and grandmother.

The boy gave police this account:

At first, Negrette took him to R-rated movies, then he began showing him child pornography at his apartment during their weekend visits. He also showed him Polaroid pictures of naked children and encouraged him to call sexually explicit 976 recorded messages.

After several weeks, Negrette tied him down with belts and performed sexual acts on him. Another man sometimes participated, and some of the incidents were photographed or videotaped.

Once, another youth performed sexual acts on the boy while Negrette and the other man took pictures. The boy said Negrette identified the youth as a Boy Scout.

According to the investigative report, police believe they have located the youth, but the youth said he barely knew Negrette.

In the course of the investigation, Huntington Beach police also were told that in 1988 some boys in the Santa Ana Scout troop reported that Negrette had shown them "dirty movies." Negrette denied doing so.

Scouting officials decided that Negrette should resign his position as a Scout leader. But, according to the report, the Scouts' director of field services, Bob Booker, told other Scout leaders that the matter should not be referred to police.

Booker was on a camping trip Tuesday and could not be reached for comment.

Nevertheless, police did investigate the story and could not substantiate it at that time.

In a re-interview of boys in the troop this year, one said Negrette had shown him an X-rated film but asked him to keep it "their secret."

Two other boys in the troop told investigators that Negrette had asked them if they masturbated or had sex with girls. They told investigators his questions made them uncomfortable, but that Negrette had not tried to touch them.

Police asked that anyone with information about Negrette call Detective Chuck Thomas at 536-5957.

# Figure Lost Scouts Post

An Orange County man who Los Angeles authorities allege was involved in a child pornography ring is now being investigated by Huntington Beach police because he served as an assistant scoutmaster for a Boy Scout troop in that city.

David Negrette, 26, of Westminster was dismissed from the Scouts in 1989 for not signing the "Leadership Affidavits" of the youth groups, according to 18-year-old daughter.

He is a spokesman for the Orange County Council for the Boy Scouts of America. Negrette was dismissed, but he did say that there was "no relation" between the dismissal and the child pornography charge that Negrette now faces. Daugherty also refused to disclose the number of Huntington Beach troops.

Huntington Beach Detective Sgt. Bill Peterson said Wednesday that investigators were interviewing boys 8 to 14 years old from the northern part of Huntington Beach who may have come in contact with Negrette. He declined to be more specific.

# SCOUTS: Officials Start Huntington Beach Inquiry

Neighbors lived, neighbors of the man who always agreed to watch their homes while they were on vacation reacted with disbelief.

"It's unbelievable. There would be nothing in the world that would make me believe that he could have done something like that," said J. H. Dwyer, a next-door neighbor.

"Right at the moment, I can tell you that we have not identified any victims from Huntington Beach," Peterson said. "We are having meetings and interviewing people but we are having some difficulty in finding them."

Negrette and Jerry Hourchens, 49, of Santa Ana are being held in Los Angeles on \$150,000 and \$200,000 bail, respectively, on suspicion of soliciting young boys in Mexico to participate with them in the making of pornographic videos. Baurer, also charged, was John Baurer, 52, of Los Angeles. Baurer, a former priest, is the group's ring-leader, detectives allege, and is still at large.

### Fourth Man Sought

A fourth man, Victor Feltsman, sought by authorities for his alleged involvement. Baurer, Negrette and Hourchens all were charged with conspiracy to distribute child pornography throughout the Southwest and the United States. Hourchens pleaded innocent Wednesday to the conspiracy charges in a Los Angeles court at his arraignment. A preliminary hearing for both Negrette and Hourchens is scheduled April 21.

Authorities allege that the group lured the Mexican youths—all ages 8 to 14—into participating in the videos by paying them a few dollars. The tapes were allegedly filmed last year in motels in and around the city of Ensenada.

Detective Bill Dworkin of the Los Angeles Police Department's Sexually Exploited Child Unit said that investigators no longer believe that the three victimized only the Mexican youths, but that Huntington Beach detectives, along with Los Angeles authorities, would continue their investigation.

"As of yet we have no information to believe that either Negrette or Hourchens were involved with any boys in Orange County," Dworkin said.

### Neighbors Shocked

Neighbors of Negrette, who lived in a Westminster trailer park, greeted the news of the McDomercil Douglas Astronautics Co. employee's arrest with shock.

"He was always real nice—a quiet fellow, always well-dressed and never a problem," said Carl Dobos, a manager at the park in the 14000 block of Hoover Street. "When he was arrested, we were amazed. He seemed to just come and go from work and that's it," Dobos observed.

Dobos said the only time that Negrette had a problem in the large park was when his video camera was stolen from his mobile home last November.

"At the time, we didn't think too much about it. But after he was arrested, they took several different pieces of gear out of his trailer, including VCRs and stuff like that," Dobos added. "Along the way, he kept, free-wheeling," he said.

# 2 Seized, Ex-Priest Sought in Alleged Porn Ring

LOS ANGELES—Two Orange County men have been arrested and a former Roman Catholic priest described by neighbors as a "perfect gentleman" is being sought in connection with a ring that allegedly made pornography videotapes of young boys in Mexico and Southern California and distributed them worldwide, police said Tuesday.

John Bauer, 52, said by officers to have preyed on juveniles in Holly-

wood in recent years and to have owned porno shops in the Pacific Northwest, was labeled the "Pornographic Priest" in a 1984 Chicago magazine article that described his disillusionment with the priesthood.

Bauer, the alleged ringleader, is believed to have fled the country after slipping through police hands several months ago. Also being sought in the case is Victor Felliciano, 29, a Rosemead handyman,

who is thought to have fled the country.

The two arrests were identified as Jerry Houchens, 49, of Santa Ana, and David Negrette, 26, a former assistant Scoutmaster of Huntington Beach, said Detective Sgt. Ralph Bennett, of the Police Department's Exploited Child Unit.

Negrette was being held on \$150,000 bail. He faces a preliminary hearing April 21. Houchens is in jail with bail set at \$200,000. He is

to be arraigned today.

All four suspects have been charged with conspiracy to distribute child pornography. Bennett said they are members of the North American Man-Boy Love Assn., an organization of pedophiles that circulates child pornography.

Bennett said the suspects apparently picked up boys ages 8 to 14 on the streets of Ensenada and took them to motel rooms there to **Please see RING, Page 6**

videotape them in sexual encounters with each other and with at least three of the four men. The boys were paid a few dollars apiece, the officer said.

Bennett said the case came to police attention last summer when a young boy told authorities at Children of the Night, a Hollywood shelter for runaways, that he had been picked up by Bauer and taken to the ex-priest's apartment nearby, where he saw photographs of nude boys.

Officers went to the apartment in the 1,500 block of North Marvel

Avenue and removed a truckload of videotapes, videotaping equipment and other material. They also reported finding some marijuana plants.

Bauer was arrested Aug. 23 on suspicion of cultivating marijuana. He posted \$1,000 bail and disappeared. It was not until after he had left—apparently for Europe—that officers were able to go through the seized material and realize that pornography charges could be filed, Bennett said.

A staff member at the Hollywood shelter said Tuesday night that police told her "this guy [Bauer]

has been doing it [videotaping young boys] for a while."

"We had heard about him from more than one child," the woman, who asked not to be identified said.

Lucille Hotnog, the manager at the apartment building where Bauer lived, described him as "a rather attractive gray-haired gentleman with glasses." She said that he appeared to be a retiree and that he told her that he "accrued a lot of money—T-bills, trust funds. He often swam in the daytime, or lounged by the pool."

Bauer's apartment was remodeled before his arrest, Hotnog said,

"but when the construction workers went in, there were no pictures or unusual plants. I had no suspicion. I didn't see him with one child, only with adult friends."

Nathan Chew, a neighbor, remembered Bauer as "the guy who was always wearing Hawaiian shirts. The only people I saw him with were his age—older guys."

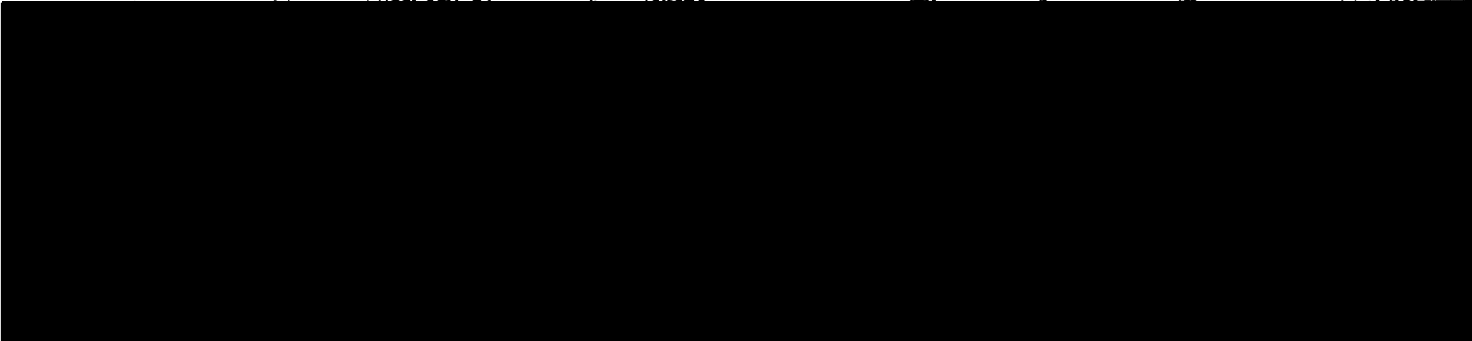
