If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.


TO WHOM IT MAY CONCERN:

Please be advised that Donald E. Gibson (See Appendix A) entered a plea of guilty and was convicted 5/17/82 on two counts of corruption of minors in the Court of Common Pleas, Mifflin County.

These offenses occurred in July - September 1981 and involved Mr. Gibson taking two young men to his mobile home and sexually assaulting them.

As a result of this behavior, he was sentenced 9 months to 23 months at the Mifflin County Jail. As a result, I feel it would be inappropriate for him to resume being a scout leader in the future.
