Complying with a request from David Park, I am submitting information concerning the above named former employee.

On Monday evening, February 26th, Keith Carpontier called our San Francisco store manager, Maury Griffin, and informed him that as of the previous day he had resigned from our Scout shop. Appropriate action took place on Tuesday in order to obtain a final check for him. On Thursday, March 1st, a policeman from Milpitas, California called our store and spoke with the assistant manager, Linda Connors. He was asking questions concerning the whereabouts of Keith and informed Linda that he was a suspect in a child abuse case.

Keith was born in August of 1933, stands approximately 5ft. 10 inches tall and weights approximately 160 lbs. He has a slight build with grey hair and gives the appearance of being older than he actually is.

This information is being supplied to you for use in whatever way you deem necessary. It is my understanding that within the last few years he has not acted in a volunteer capacity for the organization. If I receive any additional information concerning this situation I will be happy to inform you immediately.

Jerry Jennings called me on March 2 and indicated a problem with this individual. He had been employeed by our Scout shop in San Francisco, since October 1988. He previously had been employeed by our Distribution Center. Apparently, a few days ago Mr. Carpontier suddenly quit on a very short notice and ask that he be paid immediately. He was paid in cash. Later police detectives approached the Scout Shop and asked about Mr. Carpontier. When the police were told that he had quit, they ask if he was going to come back to get his check. It was then indicated that he had been paid in cash.

The detective indicated that they had been to his home; it was empty and he had already moved and gone. Apparently, there was some concern about a child molestation charge.

We will set up a temporary file, until we get more information related to this and see if he has been arrested and actually indicted.
