

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

We would like a copy of a paper with Mr. Smeby's signature if you have this available, as this aids in the identification process. Any applications, advancement reports, or any other form with his signature would be helpful.

We would also like to know if you gave Mr. Smeby a letter of suspension? If  $you^-or$  the Chartered Organization did this, we would like to have a copy of this particular paper.

You also indicate that the police had been notified that the leader had been nude with youth. Was there some sexual act performed, or can you get other information related to this? We would like copies of newspaper clippings, court records, or police reports if these can be secured, as these would aid in the identification process and also support our refusal of registration at a later time. Please do not hesitate to contact us if you have any questions, and send us whatever material is available for our files.
