Personally appearred before the undersigned officer authorized by law to administer oaths, who after being first duly sworn deposes and says on oath the following:

- 1. That deponent is age 29, whose permanent home is Augusta, Richmond County, Georgia 30906, and whose current address is Montserrat, British West Indies, Leeward Islands;
- 2. That this affidavit is made on personal knowledge of deponent of all the facts stated herein;
- 3. That this affidavit is made for any lawful purpose or use in connection with the subject matter stated herein;
- 4. That during the period 1976 to 1986, deponent was employed in the laboratory of St. Joseph Hospital, Augusta, Richmond County, Georgia, and in the course of that employment deponent had frequent contact with Earl Andrew Rimer, who was then employed as a contract employee with the same laboratory;
- 5. That in about the Spring of 1977, while defendant was accompanying Earl Rimer in Earl Rimer's car to Thomson, Georgia, to pick up medical specimens for processing by the laboratory, Earl had a cooler of beer and encouraged deponent to drink more and more beer, which deponent declined to do;
- 6. That deponent had to stop and relieve himself on the side of the road and Earl Rimer did the same, upon which deponent noticed that Earl was glaring or paying a noticeably inordinate

and unusual amount of attention to deponent's act of urination;

- 7. Upon resuming driving, when deponent declined to drink any more beer, Earl Rimer verbally tried to get deponent to drink more beer and then told deponent to undue deponent's pants so he could hold more beer;
- 8. When the stated efforts failed to get deponent to do as Earl Rimer requested, Earl leaned over from the driver's seat and twice attempted to undue deponent's pants, whereupon deponent pushed Earl away each time, and on the second time, deponent had Earl stop the car and deponent got out and began walking back to Augusta;
- 9. After deponent had walked some distance, Earl Rimer drove up and offered to ride deponent back to Augusta; deponent got in the car and Earl drove very fast to the hospital;
- 10. When dponent got out of the car at the hospital, Earl said, "Call me when you come to your senses;"
- 11. Deponent understood at the time of the stated incident that Earl Rimer was attempting to engage deponent in a homosexual act.

Personally appeared before the undersigned officer authorized by law to administer oaths, who after being first duly sworn deposes and says on oath the following:

- 1. That deponent is , age 18, whose permanent home is Augusta, Richmond County, Georgia 30909, and whose current address is Athens, Georgia;
- 2. That this affidavit is made on personal knowledge of deponent of all the facts stated herein;
- 3. That this affidavit is made for any lawful purpose or use in connection with the subject matter stated herein;
- 4. That deponent has known or known of Earl Andrew Rimer as an employee of St. Joseph Hospital for most of deponent's life, as deponent's father is a medical doctor and pathologist with St. Joseph Hospital and has been such since before deponent was born;
- 5. That in the course of visits to the laboratory in St. Joseph Hospital deponent has had occassional contact with Earl Andrew Rimer, who has been employed with the same laboratory for as long as deponent can remember;
- 6. That on Thursday, 6 November 1986, while deponent was accompanying Earl Rimer in Earl Rimer's car to Jacksonville, Florida for the Georgia-Florida football game, together with another Freshman at the University of Georgia, Earl had a cooler of beer and other alcoholic drinks, which Earl had several drinks and encouraged both of us to drink, which we did;

- 7. That night the three of us slept in two standard size beds in a motel rented by Earl;
 - 8. Earl and deponent slept in the same bed;
- 9. At about 3:00 A.M. that morning, which was Friday, 7 November 1986, deponent woke up to find that Earl Rimer was lying right up against deponent and Earl had his hand on deponent's penis;
- 10. Deponent brushed Earl's hand away and went back to sleep;
- 11. The next afternoon, deponent confronted Earl, told Earl that what Earl had done had upset deponent, that deponent wanted to leave;
- 12. Earl begged deponent not to leave or say anything about the incident and deponent, wanting to see the Georgia-Florida football game for which deponent had come, agreed to remain on Earl's assurance there would be no further such conduct as had occurred in bed the night before;
- 13. Deponent slept on the floor the remaining two nights and there were no further homosexual approaches made to deponent by Earl;
- 14. When deponent mentioned the incident to the other Georgia freshman, also a male, the other freshman did not appear surprised and indicated knowledge of a similar approach to another boy on another occassion.
