THE GRAND JURY OF ORANGE COUNTY, by this Indictment, accuse EDWARD D. SPEAR of the crime of RAPE IN THE SECOND DEGREE, in violation of the provisions of Section 130.30 of the Penal Law of the State of

New York, committed as follows:

The said defendant, on or about and between January 29, 1978 and January 29, 1979, in Orange County, State of New York, being a male more than eighteen years of age, engaged in continuing acts of sexual intercourse with a female less than fourteen years of age. Said acts of intercourse being committed during the period set forth in this count as part of a common scheme and plan of criminal acts in violation of the provisions of Section 130.30 of the Penal Law of the State of New York.

SECOND COUNT

And the GRAND JURY AFORESAID, by this Indictment further accuse EDWARD D. SPEAR of the crime of SEXUAL ABUSE IN THE SECOND DEGREE in violation of the provisions of Section 130.60 of the Penal Law of the State of New York, committed as follows:

The said defendant, on or about and between January 29, 1978 and January 29, 1979, in Orange County, State of New York, did subject a person less than fourteen years of age, to sexual contact by touching her sexual and intimate parts in order to gratify his sexual desire.

May 17, 1982 - Conference adjourned to 5-24-82 at request of defendant. Defendant continued on bail.
