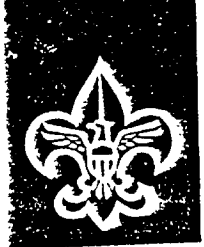

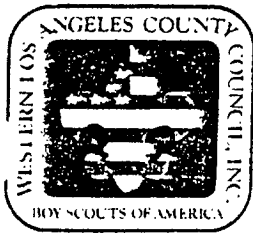

This is just to keep you informed. At this time we are not involved, other than contacting the Scouting representative of Troop 185, sponsored by St. Matthew's Episcopal Church, who relieved Edward Dillingham as Scoutmaster.

We are enclosing a copy of Case No. 8708-21841, accusing Edward Dillingham of Child Molestation. Our records indicate subject's birthdate as May 1935. After reviewing the records, I see that this birthdate has been changed, in pen, to February 1950. Subject's address is [redacted] Pacific Palisades, CA 90272.

This was not a Scouting function and, therefore, we are taking no further action at this time.

VICT STATED THAT AFTER THE GAME SEVERAL OF HIS FRIENDS WENT TO THE DILLINGHAM RESIDENCE, WHERE THEY THEN HAD DINNER. IN THE COURSE OF THE NIGHT, THE SUBJS CONSUMED A LARGE AMOUNT OF BEER,

LATER ON IN THE EVENING, WHICH WAS SUPPLIED BY SUSP-MR DILLINGHAM. MOST ALL OF THE SUBJS PRESENT WERE 15-16 YRS OLD, MALE & FEMALE.

LATER, AS THE EVENING WORE ON, THE GROUP DWINDLED TO (4) SUBJS, [REDACTED] AND VICT AND IT WAS DECIDED THAT THEY WOULD SLEEP OVERNITE AT THE LOC.

LATER SUSP-DILLINGHAM TOLD VICT THAT HE WOULD SLEEP IN ONE OF THE FRT BEDRMS ALONE.

THEN AS VICT WAS IN THE REAR KITCHEN BATHRM REMOVING HIS CONTACT LENS'S, SUSP ENTERED, STOOD BEHIND VICT BRUSHING AGAINST VICT'S REAR BODY WITH HIS (SUSP'S) FRONT BODY AND ASKED, "DO YOU NEED ANY HELP?" "NO!" VICT ASKED SUSP TO LEAVE AND HE COMPLIED.

VICT THEN WENT TO [REDACTED] BEDRM AND COMMUNICATED HIS FEARS OF THE SUSP TO [REDACTED] WHO WAS LYING ON THE ROLL OUT SLEEPER. VICT THEN REMAINED WITH [REDACTED] TO SLEEP.

LATER ON IN THE NIGHT, VICT STATED HE AWOKE AND DISCOVERED THE SUSP-MR DILLINGHAM LYING ON THE FLOOR NEXT TO HIM.

MOMENTS LATER, VICT SAID, SUSP BEGAN TO FONDLE VICT'S PENIS. VICT SAID HE MOVED AWAY, BUT THE SUSP CONTINUED TO FONDLE HIM. VICT SAID HE WAS SCARED AND DID NOT TRY TO RESIST ANY FURTHER.

MOMENTS LATER ON, SUSP BEGAN TO ORALLY COPULATE VICT. SUSP CONTINUED TO THIS ACTIVITY ON VICT AND THEN TOLD VICT, "COME SLEEP IN MY ROOM!"

SUSP THEN ASSISTED VICT UP AND BOTH HEADED FOR SUSP'S BEDRM WHERE SUSP GUIDED THE VICT ONTO HIS (SUSP'S) BED. SUSP THEN BEGAN TO PULL OFF VICT'S PANTS AT WHICH TIME, VICT THEN STATED TO SUSP, "STOP - LEAVE ME ALONE VICT THEN RIGHTED HIS PANTS, LEFT THE BED AND RAN TO THE BATHRM WHERE HE LOCKED THE DOOR AND REMAINED THERE FOR SEVERAL MINS.

MINS LATER VICT RETURNED TO THE BED WITH [REDACTED], TOLD [REDACTED] "TO BE CAREFUL - I'LL TALK TO YOU IN THE MORNING."

THE NEXT MORNING ALL SUBS AND SUSP HAD BREAKFAST AND THEN ALL DEPARTED, [REDACTED] AND VICT LEAVING TOGETHER, AT LUNCH TIME VICT COMMUNICATED TO [REDACTED] THE PREVIOUS NIGHTS ACTIONS BY SUSP.

VICT SAID THAT AFTER HE TOLD [REDACTED] OF THE SUSP'S ACTIONS, [REDACTED] TOLD VICT THAT MR. DILLINGHAM ALSO TOUCHED HIM, [REDACTED] ON HIS REAR-END.

* VICT STATED THAT WHEN SUSP BRUSHED UP AGAINST HIM, "IT WAS JUST LIKE A DOG!"
