

Had telephone call from a Miss Jones, Investigator for the Killeen Police Department. She indicated that multiple warrants were out for:

Edwin Wolfe III

Fort Hood, TX

1010

Charges were aggravated assault and sexual assault of young people ages 8 & 9. Wolfe is wanted in Fort Worth and Killeen areas.

Miss Jones also stated that the more she investigated, the more cases were being discovered.

Wolfe is presently registered as ASM of T-211, chartered by 553 Supply & Service Battalion at Fort Hood.

Miss Jones said she is working very closely with the provost marshall at Fort Hood on the case.

To our knowledge there has been no report of boys in Troop 211 being molested.

What Miss Jones has proposed - and, again, she is working with the provost marshall at Fort Hood - that the McDuff program be presented to Scouts in Troop 211.

The military police and the Killeen police are working on this together.

Wolfe presently is free on bond and on leave from his military unit in Wisconsin.

ACTION:

- 1) Council is pulling Wolfe's registration immediately.
- 2) Council is notifying 553 Battalion that he is no longer their troop's leader.
- 3) Council is contacting Public Relations in National regarding case, giving same information he related to me.
