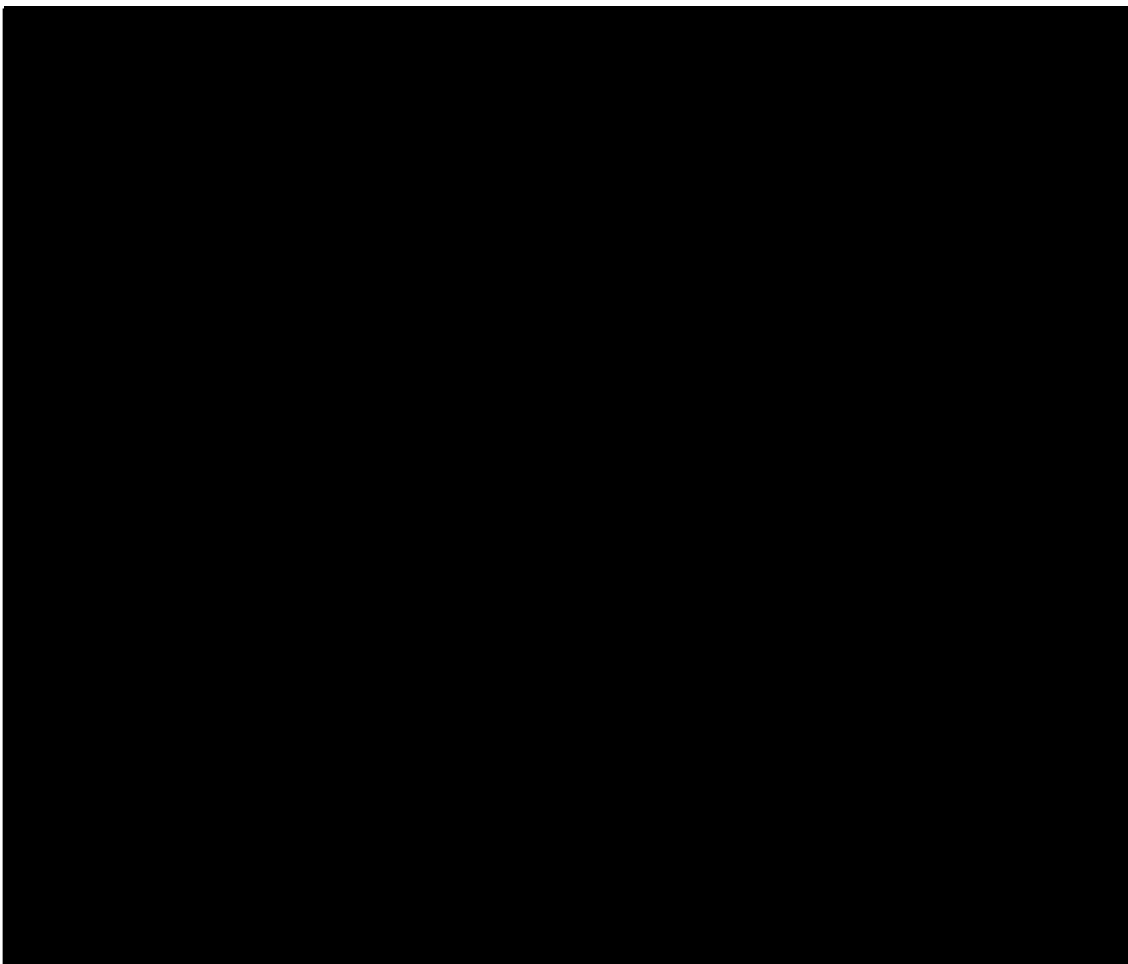

Tuesday, July 12

Big Trout

Barry Kaufman up at 7 a.m.; tried to wake Manny Neuman, but he fell back to sleep; Barry Kaufman noted that [REDACTED] was sleeping up toward top of tent, near Manny Neuman, whereas he had been curled up at foot of tent when he went to sleep (complaining of headache)

8 a.m.: Barry Kaufman went to awaken patrol leader, found [REDACTED] sleeping in tent with [REDACTED], and [REDACTED] asked why [REDACTED] had switched tents. "Not fair to [REDACTED]" (who was still in Manny Neuman's tent; Manny Neuman now awake and off fishing.)

[REDACTED]: "Mr. Kaufman, there's a problem you don't know about."

[REDACTED], [REDACTED], got dressed, talked privately with Barry Kaufman.

[REDACTED]: "Manny Neuman's being gay again!"

On questioning, Barry Kaufman was told that on Monday morning (at Lakeview site), [REDACTED] came to boy leaders and alleged that during the night Sunday, Manny Neuman; (a) masturbated in tent with [REDACTED] present (told them not to tell; Manny Neuman: "It's the only way to get rid of a boner."); (b) asked [REDACTED] to cuddle with him (he refused); (c) put his hand in [REDACTED] shorts while [REDACTED] was asleep ([REDACTED] jumped up and ran from tent). [REDACTED], also assigned to same tent, had gone to play cards in another tent; fell asleep there Sunday night.

Barry Kaufman: "Why didn't you guys come to me or the Mr. Bloom on Monday?"

[REDACTED]: "That was our mistake; we're sorry."

Barry Kaufman (to [REDACTED]): "What did you mean about 'Manny Neuman being gay again?'"

[REDACTED]: "Something like that happened to me about 4 or 5 years ago (on an A.T. trip) on one of my first trips when I was assigned to Manny Neuman's tent."

9:00 a.m.: Barry Kaufman woke up Joseph Bloom; related story.

After breakfast: Joseph Bloom talked individually with [REDACTED], [REDACTED]; heard essentially same story.

Joseph Bloom and Barry Kaufman confer; agree there is enough suspicion to warrant Manny Neuman's removal from trail.

Joseph Bloom and Barry Kaufman decided to discuss with Manny Neuman at lunch; Barry Kaufman would drive Manny Neuman to Manny Neuman's truck while Joseph Bloom took troop to rifle range at Big Springs.

During morning: Barry Kaufman observed Manny Neuman teaching knots to [REDACTED]. Manny Neuman: "You're not getting it. Here, sit in my lap and I'll be better able to show you how to tie knot." Barry Kaufman went over, told [REDACTED] to get up; told Manny Neuman: "Teach it the right way."

During morning: Joseph Bloom overheard Manny Neuman saying to young Scout: "I'll go with you to see where the willy-box is in the woods." Joseph Bloom went over, told Manny Neuman to let boy go alone for privacy.

At lunch (noon): Barry Kaufman, Joseph Bloom, Manny Neuman in lunch group away from others. Joseph Bloom told Manny Neuman of allegations. Manny Neuman denied weakly. Joseph Bloom told Manny Neuman he would have to get off trail. Manny Neuman quiet; asked how it would be accomplished. Barry Kaufman explained plan, told Manny Neuman we would tell troop that Manny Neuman had gotten an emergency phone call from home.

1:00 p.m.: Plan implemented; troop to riflery, Barry Kaufman drove Manny Neuman to Manny Neuman's truck, Manny Neuman left camp.
