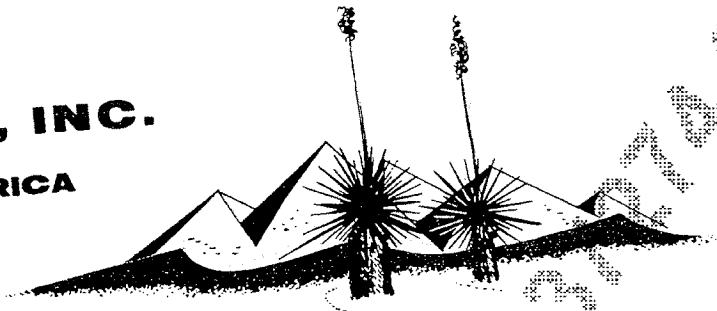

My son of troop 17, Boy Scouts of Blessed Sacrament returned from a week at Camp Dale Reeler July 9-15, he related an incident that involved an adult leader, Eugene Falcone, which deeply concerns both myself & my wife

Upon his arrival at Camp Dale Reeler he was assigned to the tent of Eugene Falcone, by Mr Falcone. That same nite Mr Falcone demonstrated some less than respectable actions such as revealing parts of his body that is normally covered, exposing the area around his penis and further handling of said. He further tried to pull open my sons fly on his pajamas which my son repelled. He then stated to my son that he wished he had a son like him, and then told him they should raffle. My son again repelled him by pushing him off his bed & told him to leave him alone or

he was going to [redacted] did leave him alone [redacted] that night according to my [redacted] but pretended to be sleeping and continued to play with his [redacted] again related that something was physically wrong, as his penis was part plastic, which to me would indicate he was displaying a prophylactic.

On the second night a recurrence of the same thing happened & [redacted] moved out of the tent into another, he was not bothered again but upon returning to his tent to get his gear Mr Falcone was found in bed displaying the same actions described above, the remaining days at camp [redacted] states that Mr Falcone claimed to be sick, stayed in his tent & would become angry if any one of the boys went near or tried to wake him, at times not appearing for meals.

The Sunday or next day July 16, I reported the incident to the Scout Master Dwight Tinkler and to Rev Fr. Roland Von Der Haar the Pastor of Blessed Sacrament Parish. The following night a [redacted] was being held. Father

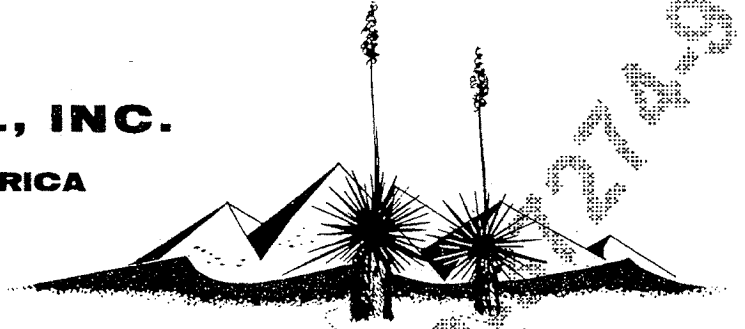
