# Teaching assistant faces 8 years in jail

Garth Eric Ratliff, 32, of Santa Barbara pleaded no contest Friday to one felony count of lewd conduct with a 12-year-old boy that occurred while he was a teaching assistant at Roosevelt Elementary School.

No promises were made regarding Ratliff's punishment when he entered his no contest plea — equivalent to admitting guilt in a criminal case — before Santa Barbara Municipal Court Judge Joseph Lodge.

He faces up to an eight-year state prison term, but could also be put on probation instead and ordered to serve a year or less in county jail, said Deputy District Attorney Ronald Zonen.

However, Zonen noted that the sentencing judge will have "to determine there are unusual circumstances in the case to grant

probation."

The prosecutor said he's unsure at this point what sentence he will recommend for Ratliff.

Neither the defendant nor his attorney, Rob Werner, was available for comment after Friday's hearing.

Lodge ordered Ratliff, who is free on his own recognizance, to appear in Superior Court on March 9 for sentencing.

For the past four years, Ratliff had worked part time as a teacher's aide for the fifth and sixth grades at Roosevelt School, according to police and court records. A Santa Barbara resident for about 10 years, he had been living at 1020 East St. since August.

He has not worked at the school since his arrest on Jan. 20 and will be automatically fired from his job because of his felony conviction on the child-molestation count.

The boy was not molested at school, police said.

According to detectives, Ratliff was a volunteer assistant with a Boy Scout troop made up of students from Roosevelt and Peabody Elementary School. Until about a

year ago, he also taught computer classes at the downtown Boys' Club.

Police began their investigation after the boy told his mother he had been molested by Ratliff and she contacted authorities, detectives said.

the victim's family, reportedly molested the boy over a three year period. Police said the boy, a former Roosevelt student, was from a single-parent family and was occasionally allowed to stay overnight at Ratliff's home, as well as go on out-of-town camping trips with the

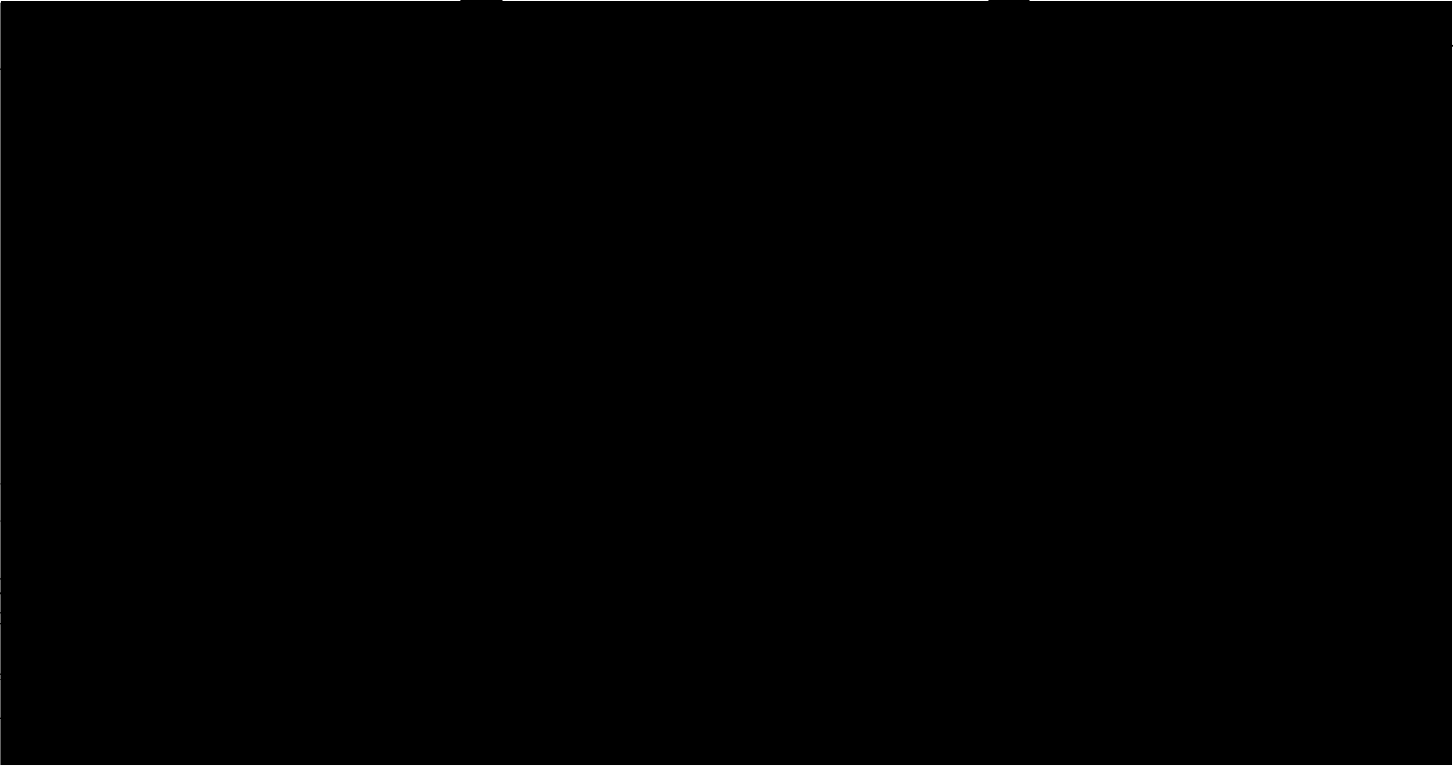

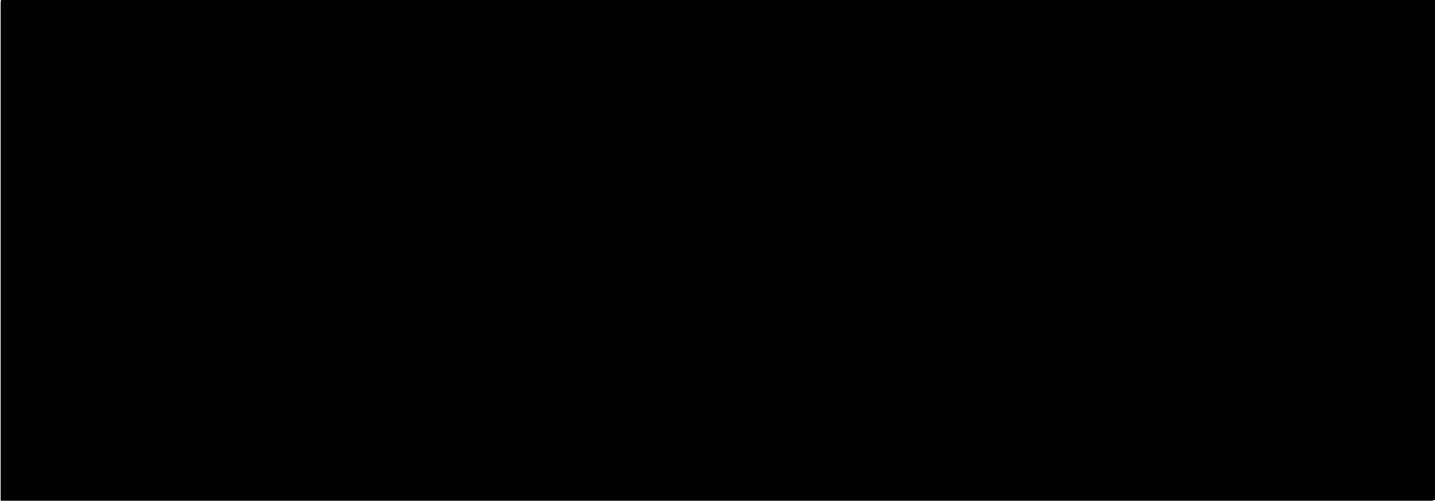
