

Since filing the report with your office, we have received information that the local Police Department has been made aware of the situation through sources other than the ones indicated above.

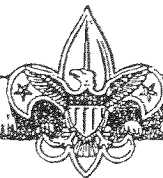
