Dear Sir:

The subject of this letter is Mr. Gene Albrecht of 1353 Cheshire, Houston, Texas. The following information is per your request by telephone on April 23, 1961.

On the night of April 22, 1961, I, my husband [REDACTED] and my son [REDACTED] were visiting in the home of Mr. R. H. Albrecht. Mr. R. H. Albrecht is the older brother of Gene Albrecht. Mr. R. H. Albrecht's address is 4010 Ella Blvd., Houston, Texas.

About 9 p.m. Gene Albrecht arrived. Our son [REDACTED], age 10, and Joe Albrecht age 8, and Cassandra Albrecht age 5 (The children of Mr. R. H. Albrecht), were playing in the yard. After being there for about ten minutes and drinking a cup of coffee, Gene went out into the yard. We could hear the children shouting and playing. Suddenly they were very quiet. I went to investigate, and [REDACTED] and Gene Albrecht came from behind the house. Being suspicious of Gene Albrecht's conduct because of some stories we had heard previously, I took [REDACTED] aside in one of the bedrooms and questioned him. [REDACTED] stated that Gene Albrecht had put his hand inside his trousers and played with him. [REDACTED] said that he started to cry out, but that Gene Albrecht put his hand over his ([REDACTED]) mouth.

I accused Gene Albrecht of this openly, and he (Gene Albrecht) denied his actions. My husband and I took [REDACTED] and left immediately.

The entire Albrecht family are lifelong acquaintances of my husband, so we have brought no formal charges with the police as yet. However, we may do so if the family does not see to it that Gene Albrecht is given some sort of treatment or put under some restraint. We feel that he (Gene Albrecht) is a mentally-sick person.

It is our understanding that Gene Albrecht has been associated with the Boy Scout movement for several years, as well as some church youth organization.

It is our contention and desire that Gene Albrecht be no longer allowed to participate in any of these youth movements, and it is the

main purpose of this letter to emphasize that point.

We have heard that he has a past record/history of child molestation. We have no facts or information ^{of} any previous offenses, but feel that the facts that we do have warrant some action in removing this man (Gene Albrecht) from direct association with any children, anywhere, anytime.

The accusations against Wes Andreen were made by [REDACTED]. [REDACTED] reported that during the closing campfire at Camp Easton Idaho ^{July 9} he retired to his tent early because his back was hurting. He did ask me if he could do this and I gave him permission. [REDACTED] reported that Wes went with him back to our troops campsite and while there Wes touched him in his privates and Wes asked if he could perform oral sex on [REDACTED]. [REDACTED] told Wes no. Wes told [REDACTED] that he had done it to another Scout (not on a scouting activity) while they were both drunk and [REDACTED] persuaded [REDACTED] to let him. [REDACTED] again said no and told Wes to leave which he apparently did. I was not aware that this took place until our next meeting July 12 when another leader reported it to me.

Dear Alan:

Per your request, enclosed is the original written statement by [REDACTED] concerning the incident with Wes Andreen. Also enclosed are the reporting forms and a detailed chronology as to the sequence of events.

Four things need to be emphasized:

1. [REDACTED] has been consistent in his statements concerning the alleged incident between Wes Andreen and himself. Additionally, it is not in [REDACTED] character to intentionally hurt anyone or to lie to get someone in trouble. In our opinion, his statement is credible.
2. Through this whole incident, we have been extremely careful to protect the confidentiality of Wes Andreen and [REDACTED]. Wes Andreen has made public the allegations through his conversations with our Scouts and other adult Scouters not associated with B.S.A. Troop 144. We never even discussed this matter with our own troop committee until after Wes Andreen put the accusations out on the street!
3. We all really liked Wes Andreen and were extremely proud when he achieved Eagle Scout. He was always willing to help the Troop out. It hurt when we had to tell Wes that he no longer had the privilege to attend our Troop meetings or participate in Troop activities. But, the risk to our Scouts had to be minimized.
4. Wes Andreen attended summer camp in July 1993 as an adult, not as a Scout (he turned eighteen (18) in March or April 1993). He has never filled out an application to register as an adult Scouter with B.S.A. Troop 144.

CHRONOLOGY

JUNE 28, 1993:

On Monday evening at approximately 7:00 p.m., [REDACTED] (mother of [REDACTED]—a new Scout in Troop 144) came down to the Scout meeting upset saying she needed to talk to [REDACTED] and [REDACTED] about Wes Andreen. [REDACTED] asked her to come back after the Scout meeting (between 8:30 p.m. and 9:00 p.m.).

Wes Andreen had been floating in and out of foster homes for some time and he was currently living in the home of [REDACTED].

The Troop had an impromptu committee meeting that night. At approximately 9:00 p.m., [REDACTED] showed up to speak to the Troop Committee (present were: [REDACTED], Dr. [REDACTED], Kathy Sheffler, Bob Knopp and possibly others). [REDACTED] expressed grave concern over Wes Andreen because she had heard that Wes Andreen had some child pornography--she claimed it came from two unverified (one of them was her ex-husband) sources and was strictly hearsay. She was extremely concerned because of the rumors and the fact that Wes Andreen (age 18) had been living in her home, sleeping in the same bedroom in the same bed with her son, [REDACTED] (age 11). Wes Andreen had met [REDACTED] through Scouts and had become his "best buddy." [REDACTED] was further upset because her son was going to Scout Camp and so was Wes Andreen. Additionally, she did not want Wes Andreen riding in her car.

Discussion was had among the Troop Committee. Since the accusations were merely unverified rumors, the Troop Committee felt no action could be taken nor was it appropriate to tell Wes Andreen that he could not go to Summer Camp as an adult leader. However, it was decided that somebody needed to talk to Wes Andreen about his obligations and role as an adult leader. Since he was scheduled for a physical with Dr. [REDACTED], Dr. [REDACTED] agreed to sit down with him and discuss with Wes Andreen the rumors and explain to him his obligations as an adult around Scouts and appropriate behaviors. This was done on Wednesday or Thursday. It was stressed to Wes his obligation as an adult to go to extreme lengths to avoid even the appearance of misconduct and not to be alone with any Scout at any time.

In the meantime, [REDACTED] was going to visit with [REDACTED] her son, to see if there were any concerns because of [REDACTED] relationship with Wes Andreen. To date, she has never reported any concerns; and, she has since moved to Washington.

Care was taken to insure that Wes Andreen would stay in the same tent at summer camp with an adult (Bob Bohac) and not with a Scout.

JULY 3-10, 1993:

B.S.A. Troop 144 attended summer camp at Camp Easton near Coeur d'Alene, Idaho. Scoutmasters attending were [REDACTED] and Bob Bohac. Other adults attending

were [REDACTED] (driver). Larry Paulsen (gear hauler) and Wes Andreen. Scouts attending were: Alan Bohac, Jason Frazier, Cory Nicholson, [REDACTED] Randy Rempfer, Zach Sheffler and [REDACTED]

Friday evening, July 9, 1993 was the final campfire at Camp Easton. It was during the campfire that the alleged sexual propositioning/solicitation occurred between Wes Andreen and [REDACTED]

It has been corroborated by the Scoutmasters attending Camp Easton that Wes Andreen was not at the campfire. [REDACTED] had been excused from attending the campfire by [REDACTED] because of his back pain. Wes previously (sometime prior to the campfire) had told Bob Bohac that he was going to take a shower. It is unknown why Wes was in camp instead of attending the campfire..

JULY 10, 1993:

B.S.A. Troop 144 Scouts and adults returned late Saturday night to Powell, Wyoming, from summer camp.

JULY 12, 1993:

On Monday morning at approximately 10:30 a.m., [REDACTED] received a call from Dr. [REDACTED] stating that [REDACTED] wanted to talk to him. [REDACTED] came down to [REDACTED] office and related to [REDACTED] essentially the same facts as are in [REDACTED] written statement. [REDACTED] had also stated that he had told his mom about the incident, but not his dad.

After [REDACTED] had related the alleged incident to [REDACTED] (with [REDACTED] permission) called [REDACTED] Scoutmaster, and stated that [REDACTED] wanted to speak with him about problems at summer camp. [REDACTED] then went over to [REDACTED] house and related essentially the same facts as are contained in his written statement.

[REDACTED] then went out to Dr. [REDACTED] house and sat down with Dr. [REDACTED] and [REDACTED] went over the incident again to reconfirm the accusations and to determine [REDACTED] and his family's state of mind. When asked why [REDACTED] reported the incident, [REDACTED] indicated that he reported it because he thought he should--it was the "right thing to do."

[REDACTED] then contacted [REDACTED] and Dr. [REDACTED] separately. It was decided among the three (3) to confront Wes Andreen and advise Wes that the Troop could not afford the risk of him working with the Scouts.

B.S.A. Troop 144 had their Scout meeting at the usual time (7:00 p.m.) A short business meeting was held and then the Scouts, under other adult supervision, went over to Washington Park to play games.

Wes Andreen was pulled aside. [REDACTED] and [REDACTED] went into an adjacent room to talk to Wes about the alleged incident. The accusations (i.e. inappropriate sexual solicitation) were related to Wes Andreen. [REDACTED] stated that neither Scouting nor he could risk his current involvement with Scouting. Wes became belligerent and defensive; he never denied the accusations. But, he did state that he was molested by an uncle and he would never molest a kid. At that time, [REDACTED] stated that Wes was not being kicked out of Scouts, but that he no longer had the privilege of attending Troop meetings and he would not be allowed to participate in Troop activities. (NOTE: Wes, at this time, was a former Scout having turned eighteen (18) in March or April of 1993. He had not yet filled out an adult application but was acting as a supervising adult!)

[REDACTED] and [REDACTED] both related that the accusations would be kept confidential, but that if Wes participated in any youth organizations or activities for a period of four (4) years that there then was an obligation to report to that organization the accusations. Wes Andreen was further advised against going back to Camp Easton to serve on Camp staff because of the allegations. [REDACTED] and Bob Bohac, since they were the Scoutmasters at Camp Easton, were told about the allegations and the course of action taken by [REDACTED] and [REDACTED]. A few days later, [REDACTED], Institutional Representative and Troop Committee Chairman, was told about the allegations and the course of action taken by [REDACTED] and [REDACTED]. Respecting the confidentiality and highly sensitive nature of the allegations for both [REDACTED] and Wes Andreen, no other Troop Committee members or Scouts were told about the allegations.

JULY 13, 1993:

Department of Family Services (DFS) was contacted by phone by [REDACTED] requesting a meeting with a social worker to report the alleged incident.

At approximately 3:30 p.m. to 4:00 p.m., [REDACTED] and Dr. [REDACTED] met with Lori Stearns, Social Worker for the State of Wyoming, Department of Family Services, at the Park County Annex in Powell, Wyoming. The alleged incident (i.e. inappropriate sexual solicitation between an adult and a Scout) were reported. Since the alleged incident occurred in Idaho, Lori Stearns stated that she would have to talk to her supervisor.

Emphasis was placed by Dr. [REDACTED], [REDACTED] and [REDACTED] that they were not interested in any criminal prosecution or punishment, only that Wes Andreen's counselor be told and that he get help.

JULY 14, 1993 to SEPTEMBER 12, 1993:

No further actions were taken by the Troop Scoutmasters. Respecting the confidentiality of Wes Andreen and [REDACTED] and the highly sensitive nature of the allegations, the matter was not discussed. The matter seemed to have run its course and Wes Andreen quietly faded from the scene.

SEPTEMBER 12, 1993:

B.S.A. Troop 144 attended the Mt. Rushmore Pilgrimage (23 Scouts and 7 Adults). At the amphitheater program, the Troop ran into Wes Andreen who was with B.S.A. Troop 244 of Powell. Wes Andreen had stated to at least two (2) Troop 144 Scouts that he was going to sue Troop 144. (As a side note, if there was any breach of confidentiality, it was from Wes Andreen and his discussions with other Scouts and other non-Troop 144 Scouters.)

SEPTEMBER 13, 1993:

Upon arriving at the Scout meeting, [REDACTED] met Wes Andreen outside who was talking with and joking with the other Scouts. Wes stated that he wanted to talk to [REDACTED] and [REDACTED]. Wes was told to come back after the meeting, that there was a Troop Committee meeting and [REDACTED] would be there. ([REDACTED] had open house at school).

At approximately 8:45 p.m., the Troop Committee ([REDACTED] Gary Moody, Judy Braten, Kathy Sheffler, and Lynn Paulsen) and Scoutmasters [REDACTED] and [REDACTED] met for their regular monthly meeting and troop advancement. Wes Andreen was in the hallway; he had apparently talked to Marci Schmidt and Frank Sherman who were down there to lend moral support. Prior to Wes Andreen speaking to the Troop Committee, it was emphasized that nothing was going to be discussed with Wes Andreen unless Wes was willing to waive his confidentiality as the matters were highly confidential and highly sensitive. Wes Andreen then came in and in a belligerent and disrespectful manner stated that he was going to sue the Troop, the Troop Committee, and the Knights of Columbus. He never discussed the allegations but he did state that he had been accused of molestation before and that he never fought it then. He further stated that this time he was going to fight and that Alan Asay, Ted Mickelson and the Casper Scout Office were behind him. Wes then left. Marci Schmidt and Frank Sherman also left. The Troop Committee was then told about the July 12th actions.

SEPTEMBER 14, 1993:

[REDACTED] contacted Alan Westberg, Central Wyoming Council, Casper, Wyoming, to advise of the allegations and possible lawsuit.

SEPTEMBER 15, 1993:

Troop 144 Scoutmasters and Troop Committee Chairman [REDACTED] [REDACTED] Dr. [REDACTED] and [REDACTED] met with Alan Westberg at [REDACTED] house concerning Wes Andreen.
