# Ex-scoutmaster gets probation in sex case

BELVIDERE — Former Belvidere scoutmaster George Miller, 52, was sentenced to four years' probation by Circuit Judge David Englund for committing sexual acts with a Scout.

Miller pleaded guilty Aug. 15 to one count of criminal sexual abuse in connection with sexual acts in 1984 and 1985, when the Scout was 14 and then 15 years old.

Englund also ordered Miller to spend 40 hours a week at a job or do public service work. He also ordered Miller to undergo psychiatric treatment.

Miller also was ordered to compensate the family of the victim for psychiatric bills they have run up for the Scout.

In addition, Englund ordered Miller to have no contact with any youth group

Boone County State's Attorned Gerald Grubb said the boy, now 16 has suffered mental problems because of his relationship with Miller.

Grubb recommended Miller be sentenced to three years in prison.

Miller told the judge: "I know what I have done was morally wrong completely. I'm sorry it happened."

Despite the crime, Miller said he feels he did some good in Scouting.

"This town is going to have a bunch of young men who soon you can be very, very proud of," Miller said.

Earlier this week, Englund sentenced Layne Volk, 61, the owner of a Belvidere self-service laundry, to four years' probation on the same charge. The case was unrelated to the Miller case.

Volk was charged with fondling an 8-year-old girl in the laundry on Sept. 12

# Miller faces trial

Probable cause for a trial was found during Friday's preliminary hearing of a Belvidere man accused of sexually abusing a teen-age boy for two years.

George Miller, 52, 931 Whitney Blvd., is charged with one count of taking indecent liberties with a minor and one count of criminal sexual assault.

Miller was arrested March 27 following complaints filed by two 16-year-old boys March 19 and 20.

16-year-old boys March 19 and 20.
Circuit Court Judge David
Englund found probable cause for a
trial after hearing testimony from
Belvidere Police Detective Larry
Pearson, who was the only witness
called at the hearing.

Pearson testified that on March 19, one of the boys, accompanied by his mother, complained that he had been sexually molested by Miller. He also told Belvidere police that Miller had molested other boys as well.

On March 20, Pearson testified, he and Detective Charles Burkhart interviewed another boy in connection with the Miller case.

However, charges were filed on only one. The identity of which boy is involved in the charges is being withheld.

Pearson said the boy who was interviewed on March 20 said Miller had oral sex with him 50 to 60 times. That boy told police the incidents occurred in Miller's house and in Miller's car in the southern portion of the county. The boy said some of the incidents which occurred in Miller's house followed Boy Scout meetings, according to Pearson's testimony.

Miller has done work as a volunteer Boy Scout and Cub Scout leader.

Miller was arrested at his house on the morning of March 27. He was taken to the Public Saftey Building where Pearson interviewed Miller.

Miller admitted to having oral sex with the boy who was interviewd on March 20, according to Pearson's testimony. Miller also confirmed the sites which the boy had said the alleged incidents occurred, according to the detective's testimony.

Investigation has revealed the acts of sex began when the boy was 14 (in 1984) and continued until March 19.

Miller, who recently got a job at Pinkerton's Inc., is in the Boone County Jail on \$10,000 bond. He is scheduled to appear for a status hearing on May 2.

# Sex charges denied

BELVIDERE — Boy Scout leader George Miller, 52, pleaded innocent Friday to charges of having sex with one of his teen-aged Scouts.

Miller, 931 Whitney Blvd., a Pinkerton Security Guard at the University of Illinois College of Medicine at Rockford, appeared before Circuit Judge David Englund for a preliminary hearing.

After the hearing, Englund found there was probable cause to hold Miller for trial on charges of aggravated criminal sexual abuse and taking indecent liberties with a minor.

No trial date has yet been set in the case.

Miller was being held in Boone County Jail Friday. His bond has been set at \$10,000.

### Sex case hearing set

BELVIDERE — Circuit Judge David Englund Friday set April 4 as the date for a preliminary hearing for George Miller.

The charges arise from incidents, dating back to 1984, with a boy who is now 16, Belvidere Police Detective Charles Burkhart said. Miller is charged with having oral sex with the boy.

Burkhart said two other teen-aged boys charged they also were approached by Miller, but no charges have been filed in connection with those incidents.

Miller said he has been unable to post the \$10,000 bond to get out of the Boone County Jail or hire an attorney because he had been laid off work for the past two years and only recently got a job for Pinkerton's Inc. Miller also has done volunteer work as a Boy Scout leader.

## Child sex charges

BELVIDERE — A 51-year-old Belvidere man was arrested Thursday and charged with having deviate sexual acts with a 16-year-old youth.

George R. Miller, 931 Whitney Blvd., who is charged with indecent liberties with a child and aggravated criminal sexual assault, was being held Thursday in the Boone County Jail.

His bond has been set at \$10,000.

Belvidere police detective Charles Burkhart said Miller is charged with having oral sex with the boy, who is now 16, over a two to three-year period. Miller was arrested in his home Thursday morning. He is scheduled to be arraigned on the charges at 9 a.m. today in Boone County Circuit Court.

# Local man faces sex abuse counts

A Belvidere man was arrested this morning on two counts of sexually abusing a juvenile, according to Belvidere Police Detective Charles Burkhart.

George R. Miller. 51, 931 Whitney Blvd.. was charged with one count of taking indecent liberties with a minor under the old Illinois Statute and one count of aggravated criminal sexual abuse under the new Illinois Statute, said Burkhart. The new statute went into effect on July 1, 1984.

Miller is being accused of molesting a Belvidere teen-age boy over the last three years, said Burkhart. The boy is now 16.

Police were first approached about the incidents on March 19 by two separate juveniles, said the detective, adding the police are continuing to investigate for other potential charges.

Circuit Court Judge Robert French set a bond for Miller at \$10.000. He will be required to post 10 percent (\$1,000) of the bond to be released.

Miller, arrested at 10:45, was placed in the Boone County Jail.

He will appear in Boone County Circuit Court on Friday at 9 a.m. for arraignment, said Burkhart.

If you wish to have this decision reviewed, please write to me, explaiming your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.


