Sgt. Tim Smith reported to me that a Gerhard Voll who lives in Moundsview at 5095 Red Oak Rd., 785-2449 and works for 3M company may have sexually assaulted an [REDACTED] DOB 10-23-69 while at the Movies at Maplewood on Aug. 9, 1979. [REDACTED] who also lives in Mounds View at [REDACTED] went to the 3M Company picnic with Mr. Voll. After the picnic Mr. Voll took [REDACTED] to the movies. Mr. Voll supposedly reached over with his hand and played with [REDACTED] penis from the exterior of [REDACTED] clothing. Supposedly Mr. Voll did the same thing to [REDACTED] twin brother, [REDACTED] on Aug. 10, 1979 up in Atkin Co., while on a camping trip. (See attached reports)

1215 Interview [redacted] with mother present. [redacted] states that Mr. Voll took him, [redacted], [redacted] and [redacted] to a JM picnic on Thursday afternoon, 8-9-79. After the picnic he asked if the boys wanted to go to White Bear Lake and go swimming. The boys said that they would rather go to a movie. They drove to a theater where Amityville Horror, Muppet Show and Meatballs was showing, plus some other movie that [redacted] cannot recall. They decided to see Amityville Horror and in the theater Mr. Voll sat on [redacted] left while [redacted] sat on [redacted] right. During the movie Mr. Voll put his hand on [redacted] crotch. He rubbed [redacted] penis through the clothing for a few minutes. [redacted] tried to push Mr. Voll's hand away and Mr. Voll finally quit after a few minutes.

Before the movie Mr. Voll had asked all four boys if they wanted to go up north with him for the weekend. He said that they could leave that night after the movie. [redacted] had called their parents but found out that neither of them could go for the weekend. When [redacted] and [redacted] got home after the movie they asked their father if they could go and their father stated that they could. [redacted] decided at the last minute that he did not want to go with Mr. Voll because he was nervous about what had happened at the movie.

On Sunday, when [redacted] came back in the afternoon, the two boys played together. While in the garage [redacted] told [redacted] that Mr. Voll had been touching him and [redacted] told [redacted] about the same kind of thing happening the night of the movie.

1305 Call Maplewood P.D. No investigators were present so I left a message to have someone call me. I also asked if Maplewood had a theater where more than four movies were featured. I was informed that the theater in question was probably the Movies at Maplewood, phone number 770-3994. I called the theater and found out that on the night of 8-9-79 the following features were playing, Dracula, Muppet Show, Meatballs, Moonraker, Rocky II and Amityville Horror.

1330 Received a call from Sgt. Greene, Maplewood P.D. I advised him of incident which I believed had occurred in his city. I also advised him that our records were clear on Gerhard Voll, 5085 Red Oak Drive, 786-2649. He requested a copy of my report.

Q. [REDACTED] will you tell me of your trip to the 3H Co. picnic?

A. Mr. Voll, my basketball coach called and asked if I wanted to go to the picnic with him and some other boys. He came over and picked us up and we then picked up [REDACTED] and my brother [REDACTED] was with us too. At the picnic we had hot dogs, faces and went down to the stream and started throwing rocks; later we played Bocce Ball and went to the fire house. Mr. Voll then asked if we wanted to go to White Bear Lake for some air. We told him we wanted to go to the movies and he took us to see Amityville Horror. We had to wait so we walked around the Mall and later went and had popcorn. In the movies about half way through he started playing with my penis. I tried to put his hand away but he kept on doing it. When the movie was over we left and on the way in the car we talked about the movie.

Q. You used the word penis. What is a penis?

A. This thing (pointed to penis)

Q. How did Mr. Voll rub your penis?

A. He put his hand inside my pants and started rubbing me and pulling on my penis

Q. How long did he do this to you?

A. 10 minutes, about

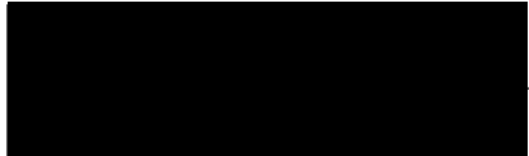

This statement is taken from Gerhard Voll, last name spelled V-O-L-L, date of birth 7-8-25, from [REDACTED], who has identified himself as a Maplewood police officer. This statement is being recorded at the Maplewood Police Department on August 16, 1979, at about 10:35 a.m. This statement is pertaining to a criminal sexual conduct which occurred on August 9th and 10th of this year.

Q. What is your full name and date of birth?

A. Gerhard William Voll, uh, July 8, 1925.

Q. Mr. Voll, uh, where do you live?

A. In Mounds View, 5085 Red Oak Drive.

Q. Do you have a phone?

A. 786-2649.

Q. Are you acquainted with an [REDACTED] and a [REDACTED] <sup>G.V.</sup>

A. Yes.

Q. On August 9th, uh, 1979, did you take the boys to a 3M picnic?

A. Yes, I invited five boys and I took them with, uh, the agreement of the parents to a 3M picnic.

Q. Okay, and after that did you go to the Movies of Maplewood and view a movie?

A. Normally I let the boys decide what we wanted to ~~do~~ <sup>do</sup> and in this case the boys wanted to go to a movie at Maplewood. <sup>G.V.</sup>

Q. And, uh, were the same five boys, did they all attend the movie?

A. Yes. They all attended.

Q. Okay, Mr. Voll, could you tell me what happened between you and [REDACTED] while you were at the movie?

A. [REDACTED] was sitting on my right side next to me, uh, at one time or another I had my hand on his upper leg and at one point, I'm not sure when it was, I touched his penis. First through the pants and I noticed he was sexually excited - that's when I touched his penis under the pants, and I looked at him and he looked at me and he said, "Mr. Voll," and then I took my hand away from him and we continued as usual. I still had my hand on his upper leg but never touched his penis again.

Q. Did you go inside of his clothing to touch his penis?

A. For a very short moment I did, yes.

Q. Okay.

A. Just touching and pulling it back. But he did not approve of it, obviously.

Q. Mr. Voll, how old is [REDACTED] <sup>G.V.</sup>

A. [REDACTED] is either 9 or 10.

- Q. And did [redacted] go on a camping trip with you on August 10th?  
A. Yes, he did.
- Q. Could you tell me where that camping trip was?  
A. Uh, the camping trip is at our Scout camp at Wood Lake, north of McGregor, Minnesota.
- Q. Is that Boot Lake?  
A. Yes.
- Q. In your own words, Mr. Voll, can you tell what happened when you got to the camping site?  
A. As we got to the camping site, I introduced [redacted] to the rest of the Scouts and they accepted him very well. He accepted the other Scouts very well - it was, I think, a happy union between [redacted] and the rest of the kids and people present at the camp area.
- Q. Could you tell me what happened on, uh, August 10th when you went to bed that evening?  
A. Uh, we could not find a camping site with the rest of the Scouts because of restricted areas there, so we had to sleep together in my tent and during the night, uh, we were sleeping close together and during the night I had been touching his penis a few times. I don't know how many times.
- Q. Did you go inside of his shorts and touch his penis?  
A. Yes, I did.
- Q. At any time did [redacted] indicate that he didn't care for you to do that?  
A. No, he did not. He was just a happy boy like he always is.
- Q. Is August 10th on a Saturday or, what day was it?  
A. Let me see. As we left the movie theater I asked his dad if I could take both boys along to the camp. I also asked the parents of the other three boys. The other three parents declined because it was too late to make arrangements. In the case of [redacted] [redacted] declined to come along. At that time he mentioned because of his uncle, I think his uncle was there and he had to leave on Saturday and he likes his uncle very much. [redacted] still wanted to come along. I offered to him to stay back to do things if he didn't want to come but [redacted] wanted to come along anyhow. And his dad agreed that he could come with me. Uh, [redacted] slept during the night, during the rest of the night in my station wagon, in back of the station wagon, while I was driving up to McGregor and to the Scout camp.
- Q. Was that the same evening that you went to that theater?  
A. Yes. But this was already the next day because I asked his dad at 12, around 12:30 at night if he could come along with me.
- Q. Okay, so you left for the camp site at about 12:30 a.m. on the 10th?  
A. Or 1:00, yes.
- Q. And [redacted] slept in your vehicle all the way up to the camp site?  
A. Yes.

A. During the night while I was sleeping next to him, yes.
- Q. Mr. Voll, did you realize that maybe you were wrong by doing this?  
A. Uh, today I was told that is a criminal act and, therefore, yes, I realize it's wrong doing - I did not realize that this would be a criminal act before I came here. No other sexual advance was ever made by me or anything else ever happen between [redacted] and me.
- Q. Did you ever have any, did you ever make any sexual advances toward any of the other boys that you've come in contact with?  
A. No.
- Q. How long have you lived in this country?  
A. Uh, since 1956.
- Q. And where are you originally from?  
A. Germany.
- Q. Where are you employed, Mr. Voll?  
A. At 3M Company, St. Paul.
- Q. And for the past several years you have been working with younger people, is that correct?  
A. For all of my life I have been working with young people, I have signed my free time up to help young kids wherever I am.
- Q. Uh, Mr. Voll, uh, after this statement is typed up and it meets with your approval, would you be willing to sign it as a true statement?  
A. Yes, I will.
