The deposition of was taken as part of the pre-trial preparation as a result of the lawsuit initiated by the mother of against Boy Scouts of America and the Catalina Council as well as Scoutmaster Cummings. Please prefer to your confidential file on William Cummings.

In his deposition, has stated that two Scouts in his troop attempted to sexually molest him. He specifically named David Beahm and Robert Burt. These two Scouts were probably involved either in VFW Post 549 or Troop 729 out of the Catalina Council.

I am providing a copy of this memo to Scout Executive Carl Jenkins. Hopefully he can provide us with further information so that you can determine whether or not Robert Beahm and/or Robert Burt should be placed on our confidential file.

said that his behavior changed a great deal because of what was going on with Bill. He claims that he became "violent at school", whereas before he had never been violent. He said that he had always avoided fights. That is a lie and we have the records to show him that he is wrong.

Another scout also got involved in Cummings' recruiting. This was a David Beahm. In ever actually saw Beahm being molested by Cummings, but he does believe it happened. Said that he and Beahm would be at Cummings' house at the same time.

He bumped into Beahm some years later, in December 1985 at the Swap Meet. Beahm was five years older than the took out to his car, and attempted to molest him. It is slugged him and left. He said that Beahm is gay.

Early on, perhaps as early as August 1982, Bill Cummings made swear on the scout oath, with his hands in a scout salute, that he would not tell anybody what they were doing. seemed to get a little emotional when he said that he had kept that promise to Bill. He said that until Bill was arrested, he never told anybody what they had done.

Bill used pornographic magazines to encourage these kids.

said that he had Playboy, Penthouse and other magazines available.

With regard to the homosexual that moved in with in November 1987, this is a strange nuance in the case, and I am not sure what to make of it. Apparently, has his first contact with after second hospitalization at Palo Verde. This would have been in December or January 1985/86.

was an orderly who would take blood. They became good friends.

claims that it wasn't until July 4, 1987, when he actually learned that was gay. He said it occurred when looked at a fellow across the street, as they were walking, and remarked that "he's cute." inquired as to whether was serious, and asked if he wasn't "gay?" He said that thought was gay, but told him that he was straight. After that, said that he and continued to be good friends, and they would tease each other. would point out "cute guys" and would point out "cute girls" for

Also in July 1987, started attending a christian gay church. He liked the people there. He felt that they understood his problems and needs. He claims that he is straight and not gay. He did indicate that his mother accused him of being gay as early as 1986.

Back to David Beahm. During Bill Cummings' hospitalization in December 1982, there were several acts of molestation that Beahm allegedly perpetrated on

little about Bill Cummings' social life. He said that on one occasion only Bill said that he was going to take an old college friend, a lady, out on a date. He believes that Cummings were a wedding band on his left hand.

Robert Burt, a scout you have heard about, was about eighteen years old when joined the troop. Burt was active in the troop, although not well liked. Once before a winter camp, Burt attempted to molest but, but zipped up his sleeping bag and wouldn't let Burt in. He never saw Burt and Cummings together. Burt never molested but. Not until May of 1983, did Burt actually move in and live with Cummings. At that time, Burt's family was moving out of Arizona and Burt needed a place to stay. He thinks they lived together for about two weeks.

The big bomb shell came when I asked regarding prior sexual molestation. It turns out that in 1979, prior to that a friend of that a friend of at Davis Monthan Air Force Base made "advances" on as a nine year-old boy. Apparently this occurred in the home, while both It happened on at least four separate occasions. On four of those incidents, this man masturbated on two of those occasions he also performed oral sex on that was when was nine.

It also appears that when was five or six, that he was also involved in some molestation. He is not sure who did it, but he knows that his mother's uncle's friend forced to masturbate him. At this time that man also had his hand on "privates." also believes that his sister was molested at that time.

The third person to molest was Bill Cummings.

I asked as to whether or not he had told the truth in the hospital about his sister. As you know, stated in the hospital that he had sex with his sister. Said that was a lie, that he had made it up in order to get back at his sister who had "left him" at a time when he needed her support, that is, after the molestations by Cummings became well known, his sister moved out to live with that he has told Dr. Maier that this was a lie and that it never happened.
