Probation is given local man

Jeffery Lloyd Bump of Crockett pleaded guilty to indecency with a child and was given a probated sentence in district court Thursday.

Bump was given a five-year probated sentence and fined \$250. He was also ordered to attend the psychological counsel program as designated by his probation office and he must not be alone with any juveniles other than members of his family.

Bump could have received up to 20

years in the department of corrections and a fine of up to \$10,000.

The defendant waived his right to a trial by jury and for representation by an attorney. The District Attorney Don Gordon,

said he believed the punishment was reasonable "under the circumstances because he (Bump) will be forced to seek some kind of treatment. That is a better solution than sending him to TDC"
