Sorry, I could not be of more help.

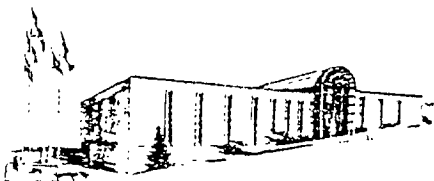

Dear Joe:

I received a letter dated November 1 from Dave Buerklin concerning the above named youth member.

I believe that Jeff should be placed on our Ineligible Volunteer File and should not be registered with the Boy Scouts of America. A sixteen year old who sexually molested a ten year old certainly does not have the character that we need in the Boy Scouts of America. It is unfortunate that this youth has problems, but we do not plan to be a rehabilitation center.

I am enclosing an Ineligible Volunteer Record sheet which I would like to have completed, so we can identify Jeff should he try to register in some other location.

I believe this is all we will need in order to maintain a file. No letter will be necessary at this time. This really would not protect us while he is a youth, but it will protect us once he becomes an adult, as this would kick out of our file should he attempt registration.

Thanks for giving us as much material as you can that would help us identify Jeff in the future.

Dear Paul:

This incident is a tough one to call and classify. This youth is protected by law, I'm told, and he should not be discussed said the State Counselor.

Scout Jeff Shuty, formally of Troop 173, was age 16 on March 1989. He was in the French Creek Council, Erie, Pennsylvania and seeking re-registration in Allegheny Trails Council.

Shuty is convicted of rape and adjudicated a juvenile delinquent. He raped a 10 year old female child. Jeff Shuty may be retarded. He comes from a broken home is raised by his grandmother, aunt and sister. I'm told that neither Jeff or his brother "were very popular in the troop or neighborhood" - said his Scoutmaster William Fincke.

Jeff's grandmother alleged that Jeff's sister was raped by the little girl's (victim) brother.

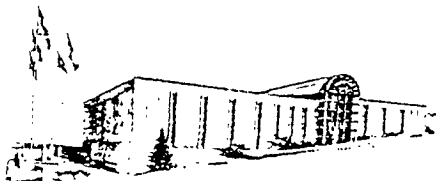
I became aware of the situation, when the youth worker from the Harbor Creek Youth Service, [redacted], Pittsburgh, PA 15235 called to get Jeff in a troop and finish his work toward Eagle.

Files are not available to us due to Jeff's age. Most of the information came through the Scoutmaster who was told all this by Jeff.

In my conversation with Officer Randolph A. Matuscak [redacted] he more or less verified this information.


Paul, how do we make him an ineligible Scout?

1. He is not registered (the troop did not register him purposely.)
2. We are not supposed to know about or publically discuss it.
3. The State will not substantiate this information.
4. Who would we deliver the ineligible letter to?
5. Mr. Matuscak requests that Jeff be reinstated. I said I don't think so and he asked permission to have his grandmother make the "plea" I said OK! -- She did -- and I said -- No -- with sensitivity and perception. We have heard nothing since. I assume they are no longer pursuing re-registration.
6. However, it seems to me we should protect youth in the future from Jeff.

My suggestion is that we don't open this up, but file an ineligible Scouter "ALERT" for the future.

Please refer future correspondence to Joseph C. Petroff - as I retire this date.
