

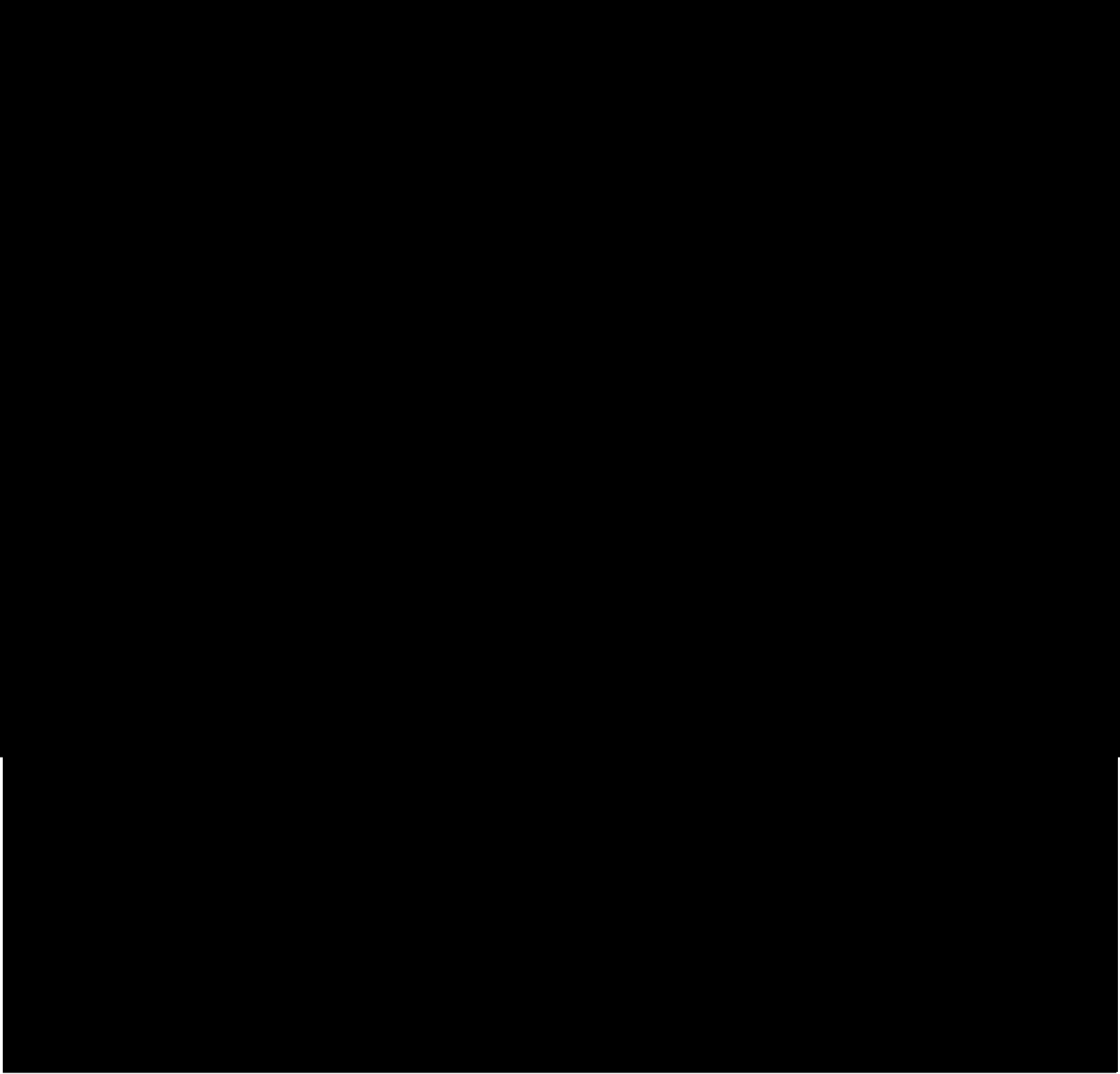

Attorney Joseph McNulty, while investigating a sexual abuse allegation involving scout youth [REDACTED], learned from the police records, specifically the statement obtained from [REDACTED], that he had been sexually abused by Scoutmaster Jess Stonier. Jess Stonier had been Scoutmaster of Troop 178 associated with the Valley Forge Council from January 1981 through December 1986. It is alleged that Jess Stonier, while naked, climbed into a sleeping bag with scout youth [REDACTED] and [REDACTED]. As a result, the troop has tried to make sure that Mr. Stonier is no longer involved in the troop and has nothing to do with the children. However, there is no indication that this was reported to the Valley Forge Council.

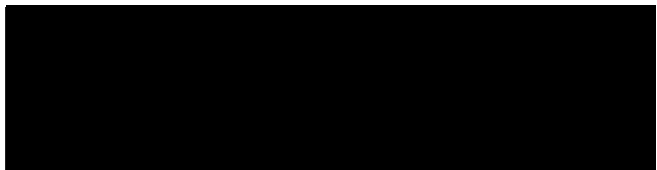
It is my recommendation that an ineligible volunteer file be created on Jess Stonier.
