

A 48-year-old St. Johnsville ma. was incarcerated in the Mon tgomery County Jail following his arrest last night by the Fonda State Police Bureau of Criminal In vestigation (BCI) on two counts o sodomy.

Police said John El Myhre was arrested on charges of third degreand second degree sodomy, Class I and C felonies. The suspect alleged ly had deviant sex with boys ages 1. and 14 last summer in the Towns o Caroga and Oppenheim, State Police reported.
