

I am writing you regarding the situation of Mr. John R. Ulvilden. I am sure you are aware of the fact that he has been arrested for immoral conduct but I thought it best to inform you that we have taken steps to have National Council place Mr. Ulvilden on the Confidential File List to make sure that he shall not be registered with the Boy Scouts of America in any capacity again. It's my understanding that he has admitted his guilt, and therefore, there is no question in this regard.

We advise you to immediately inform him that he can no longer continue his activities in Scouting and suggest that you secure all of the Troop files and other Troop equipment that he may have in his possession.

It's indeed too bad that this has happened but it is fortunate that it has not come to light through his direct connection with Scouting. I hope that as the case unfolds we do not find that his Scout's have been involved in the matter. If you have questions you would like to ask or information you would like to give us I would be happy to discuss the matter personally at your convenience.
