Enclosed are two confidential report sheets from Suffolk County Council for your information.

The first, John Stella, has been arrested by the Suffolk County Police Department on 27 counts. He was suspended by letter since we were not able to reach him with a personal contact. The day after we sent our letter to him we received the attached letter from him removing himself until his name can be cleared. Although the Stella letter is dated March 13, the envelope is dated the 17th. I honestly feel that he knew our letter was coming or he received it. I would expect that we will get the return receipt from the Post Office Department today in our mail saying someone accepted the letter at the Stella home.

The second sheet is on Scout. I am enclosing notes of a meeting we held with parents, Scouts, and Unit Leaders concerning this case. It is my feeling that this started out nothing more than horsing around and probably went too far. One of the parents of the Scouts happens to be an attorney and I think he has convinced the other parents not to drop the follow through on this one. I have contacted the Hot Line, gave them my statement over the phone, which they said was adequate and no other action of the Council was necessary. They have turned it over for investigation. The suspension letter to was hand delivered in my meeting with him and his parents.


I will keep you informed as to anything additional that we hear in either instance.
