Local Scout Master charged with child molestation

Kenneth Robert Labelle, 28, of Payson was arrested on April 18 and charged with four counts of child molestation.

Labelle, an electrical contractor, was arrested by the Payson Police Department on information which surfaced through a family counseling session with a pastor. The police were notified by Labelle's family.

During the course of the investigation it was discovered that the molestations had been occurring over a two year period.

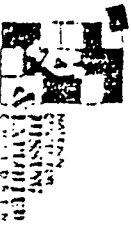
Although the victim was a member of a scout troop of which Labelle was the Scout

Master, the Payson Police Department at this time does not believe Labelle had sexual conduct with any other members of the troop.

"We have not interviewed all (15) of the boys yet, however of those interviewed, preliminary

indications are that Labelle has not made sexual advances toward them," said Payson Police Captain Gordon Gartner. According to Gartner, Labelle has admitted to the offenses and is currently being held in the Gila County jail on a \$100,000 bond.

Fayson has had its share of criminal activity ranging from burglaries to drug related crimes. We have also had our share of what some may call one of the most disgusting and repulsive criminal acts known to man...child molestation. In 1986, the National Center

For Missing & Exploited Children published a manual titled "Child Molesters: A Behavioral Analysis" for law enforcement officers investigating cases of child sexual exploitation.
For the purposes of the book, a child molester was defined as a significantly older individual who engages in any type of sexual activity with individuals legally defined as children (under 18).

Dictionary contains a layman's definition for pedophilia: "sexual perversion in which children are the preferred sexual object."
Law-enforcement investigations have verified that pedophiles almost always collect child pornography or child erotica.
Last Saturday, April 28, many Payson residents picketed local stores which sell pornography.

"Pornography does play a part in most sex crimes," said Captain Gordon Gartner of the Payson Police Department, "including child molestation."

Most people view child molesting as a serious, delectable crime. Even other criminals abhor child molesters.

...show physical affection, and express your love and confidence with words, and gestures. Avoid challenges starting with "why", such as "Why didn't you tell me this before?" or "Why did you let it happen?" Give positive messages, such as "I'm proud of you for telling me this, I'm

We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me with 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated.
