

## Dear Paul:

Per our phone conversation on 3-21-90, Mr. Shinn was not found guilty on any charges, but the following is grounds for our concern.

In 1982, Mr. Shinn was found not guilty by a jury for indecent liberties with a minor. Many still feel if that had happened now, he would have been convicted.

In 1988, Mr. Shinn was picked up leaving a barn and believed to have been having sex with the animals. The State of Illinois has no law against that act, so he only could have been charged with trespassing. No arrest was made.

Mr. Shinn never requested a review.



Dear Larry:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a 8SA member should be reinstated. The procedures for a review of this decision are attached.

I have written to the council four times over the past year asking for more information and have received no response. I do not know why the Suakee Area Council, No. 141 has been so reluctant to communicate with me.

I am enclosing another Ineligible Volunteer Record Sheet which I would like to have completed, so we can identify Mr. Shinn should we place him on our Ineligible Volunteer File. I would appreciate your help in getting this information completed by the local council.

We, also, have asked for a copy of the letter which was sent to Mr. Shinn suspending him, but so far we have not received a copy of this correspondence. This would be helpful for our file.

We would like something in writing that would help to substantiate our refusal. We need something concrete that will document Mr. Shinn is a risk of some type.




