Around 1968 I was in the boy scouts in san Antonio.

I believe the troop number was 212 sponsored by

mary magdelan catholic church. My scout leader
was a man named offo strauss. As I remember him
he was overweight and balding. I believe the street he
lived on was called

the street.

I avit scouting because one day ofto approached me in the hallway of his house, picked me up off my feet and locked me in a bearhug type embrace. he forced a very wet mouth to mouth kiss on me and tried to get me to open my lips. he was slobbering all over my mouth and chin, he seemed very agitated. he told me that he loved me and asked if I loved him, not knowing how to respond, I said yes t love you, he then released me. I left his house and I never returned,

I tild my mother t wanted to airt scouting but It was sometime before she managed to drag the reason out of me. I somehow felt ashamed and felt thwas to blame for this. as a young boy I didn't understand that what had happened was not my fault only that it was somehow not normal,

You asked me to write down everything I remember.

To realize twenty years have passed so only a few things come to mind. I will relate them as I can but I'm not sure of the cronological order in which they occured.

when the boys would spond the night at his house, say before a camp-out or Jamborce, he would let two on three boys sleep in his bed with him. They slept naked because he told us it was natural. I think some of the boys work their underwear though. I only remember one of the boys names, it was . he and brother were in other den or group. I forgot what the scouts call the small groups.

I never witnessed any explicate sexual activity between ofto and any of the other boys. nor do I remember any boy discussing anything with me. I only rember remember a vague underlying feeling I had at the time that something secret was going on around me. like there was a secrete that the only way I can explain it.

was a secreta that's the only way E can explain it.

I remember he was also a chiropractor, he had a room with a big leather examanation table and charts all over the walls of the human body. I contremember anything happening in that room but just the thought of that room today strikes fear in me.

I remember him telling us about the facts of life and discussing such things as erections with us. he had myself and a couple other boys in the bethroom one time and was showing us how we could sit on the toilet backwards to pec if we woke up with an erection. he wanted each of us to sit down and try it. I think everyone was dressed andit was tost a discussion but as I said before it was twenty years ago and my memories have faded or been buried since then. I'm sorry but this is all I can say for sure about what happened.

En all the years since this happened I have worried that he might have done something worse to other boys, my consience always told me that someone else must have come forward and spoke up to get him out of scouting, let me tell you

It hit me like a ton of bricks when I found out he was still active in the scouts. I have managed to bury the pain of what happened in the years since but now bringing this out has caused me a lot of turmoil. all I want is to keep this man away from young boys! as I said to you, I want my home location kept away from otto. I have a lot of fear about this man. I was terrified when he found me after I moved away from san Antonio. my mother felt that no one would believe what I knew about otto because he was a pillar of the community, she said nothing and we moved to colorado.

one day I was working in the yard and he drove up in his van. it was an old international van, green I think. anyway, he appeared in my front yard in Colorade with a von full of boys and asked me to come camping.

I gave him the cold shoulder and he left, I was very much afraid of him by then and the fear still lingers.

my mother has discussed this with father Pilley at mary imag delens in San Antonio. He suggested we got the Authorities with this, I have discussed it with people in the police department up here and I am waiting a refferval to someone in texas. I was told by the police to go ahead and contact the boy scouts with my story so I called the hational headauarters and spoke with lee sneath. I assume he related my story to you. I want to thank you for responding so Promptly. As for now, I am doing as you asked and sending this in writing to you. I will await further communication from you as to your action.




