Police Charge Man With Morals Counts

Owen Ronald George, 24, of 812 Tucker Street, was charged with corrupting the morals of a child and indecent assault following his arrest early today at 1618 Catherine Street.

George was charged by Det. Lt. Charles J. Sholder with the two counts involving a 10-year-old girl from Eastress, Williamsport, RD 3, he allegedly had with him at the Catherine Street address.

He was arraigned before Police Magistrate William D. Mancini and, in default of \$2,000 bail, committed to the County Prison for a hearing next week.

More Morals Charges Filed

Three morals charges were filed against Owen Ronald George, 24, of 812 Tucker Street, this morning by Det. Lt. Charles J. Sholder.

Charges of sodomy, solicitation to commit sodomy and corrupting the morals of four, eight and nine-year-old East End boys, were lodged against George before Police Magistrate William D. Mancini.

George was charged last Saturday morning with corrupting the morals of a 10-year-old girl and indecent assault, following his arrest at 1618 Catherine Street. On those charges, he was committed to the County Prison in default of \$2,000 bail.

Today the magistrate increased his bail to \$4,500 on all charges. In default, he was recommitted to prison for hearings to be held next week.
