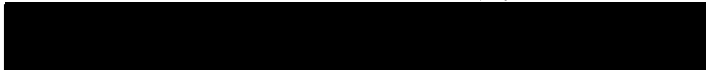

We have removed Prescott Louis DeJean III from our records. The report that caused this action came from Mr. T. R. "Toni" Turk who is assistant superintendent of schools in Port Lavaca. He also serves as District Chairman for the Indianola District and as the Branch President of the Port Lavaca Branch of the LDS Church.

Toni called me on the after noon of Friday, March 22, 1991. He told me of the discovery which came from a school referral to [redacted]. He met for several hours with Mr. DeJean in his role as Branch President and then as District Chairman, verbally relieved Mr. DeJean of his position with the Boy Scouts of America. Mr. DeJean understood and also knows that he can never join the BSA again.

As the key volunteer in that district, I asked Toni to gather the information needed for the ineligible volunteer file. (see attached). All required reporting has already taken place. I have assigned the Field Director of that service area to present the attached letter to Mr. DeJean with Mr. Turk.

If other documentation becomes available, I will forward it to you. Please place Prescott Louis DeJean III in the ineligible file.

You will be pleased to know that Mr. DeJean has already been replaced in the troop and the process to replace him in the pack has started.


Dear Mr. DeJean:

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore completed to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand the BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

The following information is provided should you desire a review by the South Central Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: South Central Region, BSA, 1329 Walnut Hill Lane, P. O. Box 152325, Irving, TX 75015-2325. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.
