In response to your letter marked Confidential, April 9th, our Scout Council has taken the following steps:

- 1. Mr. Richard Evans was not yet officially on the rolls as Scoutmaster of Troop 506 at the time the incident with your son took place (March charter expiration date): and in view of your statement we will not permit him to register with our Scout Council in any leadership position, or in any capacity which would permit him to have any contact with the Scouting program whatsoever.
- 2. Our local district representative has met with your Troop's Scout Committee and they have selected a new Scoutmaster, Mr. Alan F. Paquin. His position as the Unit Leader was made effective as of April 13th, 1971.
- 3. Further, we have notified our Regional and National offices as to the character of Mr. Evans and he will never again be permitted to register with the Boy Scouts of America.

We regret this unfortunate tragedy occurring to your family and sincerely appreciate your cooperation in these trying times for you. We are glad to hear that is doing well and are hopeful that time and loving guidance will help him overcome this personal tragedy. Please pass on to your son this hard-bound copy of the 1910 Boy Scout Handbook which has been signed by our Scout Executive and myself.

Dear Scout Executive,

On Friday April 9th. 1971, Richard Evans, Scoutmaster of our Sons Troop #506 in South Hammond, spensored by the Orchard Drive F.T.A., did willfully and knowingly sexually molest our sone, in his home in Highland.

We have had this matter varified by our family Doctor, Ralph Lunderberg M.D. in Griffith, and by St. Margerts Hsopital in Hammond.

In addition we have swarn testmony against Mr. Evans and have had him arrested in Hammond on Saturday April 10th. We suggest that you and your office take proper action and see that Mr. Evans is removed from any active roles as a scout leader with our Boy Scout Troop.

Please know that our son is doing fine at this time and that he has not been physically handicaped. Do call on us if we can be of further assitance.

Respectfully submitted
