
This will acknowledge receipt of your letter dated March 7, 1989 to Mr. Tidwell and myself.





Sub: Letter of Suspension

The letter of suspension to Richard W. Shaffer was delivered by John Dudley, witnessed by volunteer Art Ramirez and handed to Mr. Shaffer in the living room of his home located at [REDACTED] Indio, CA, at 7:00 A.M.

John Dudley made it very clear to Mr. Shaffer he is not to wear the Scout uniform, attend any meetings, dinners, activities, etc related to Scouting in any way or anything to do with the Order of the Arrow.

Mr. Dudley made it very clear, that Mr. Shaffer is to disassociate himself from the program. Mr. Shaffer stated that it was OK for him to participate if he only attended the adult portion of Scouting. Once again, Mr. Dudley made it very clear he is to disassociate himself from Scouting, including adult activities.

Dear Mr. Shaffer:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that Boy Scouts of America membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the Boy Scouts of America seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America member should be granted or reinstated.
