### Castle Shannon

A Castle Shannon man will stand trial in criminal court on charges that he sexually assaulted two girls.

District Justice Jules Melograne ordered Robert C. Henrikson, 36, of lo stand trial on charges of rape, statutory rape, involuntary deviate sexual intercourse, indecent assault, attempted involuntary deviate sexual intercourse and corruption.

Henrikson was in the Allegheny County Jail in lieu of \$10,000 bond.

County police said in one incident, Henrikson is accused of wrestling with a girl at a house in West View, fondling her, exposing himself and then attempting to sexually assault her. Police did not release the age of the girl but said she now lives in a South Hills community.

In a second incident, police said Henrikson is accused of raping a 12year-old in an unspecified South Hills town. No details were released.
