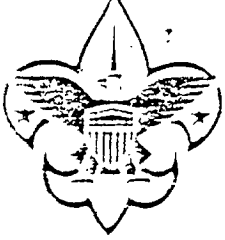

CHRONOLOGY OF EVENTS

August 12, 1987
Approximately 10:00a.m.

[redacted] and [redacted] requested to meet with me privately in my office along with Darrell Lenamond - at this time [redacted] told me that he had been the victim of an overt sexual advance by Robert Kerns, the Base E.M.T. and Dive Instructor. [redacted] related that a similar incident had been related to him two weeks previously. I told the two individuals to speak to noone else about the matter and that I would handle it.

Approximately 10:30a.m.

I called Ralph Jordan, Director of Outdoor Program in the National Office for advise. He told me to get a written statement from [redacted] and [redacted].

Approximately 12:00noon

I called Robert Kerns into my office and without accusing him, asked him the question? Robert, do you have a problem with homosexuality? His response was, I don't think so. At this point, without a confession I asked both the youth involved to write a sworn and witnessed statement of exactly what occurred, those statements are enclosed.

Approximately 2:00p.m.

I called Ralph Jordan and read excerpts of the statements he requested that I prepare a letter as found on page 24 For Suspension of a Registration in the Sexual Abuse Awareness Book. He asked me to wait until we had advise from National legal council who was at that time traveling.

Approximately 4:30p.m.

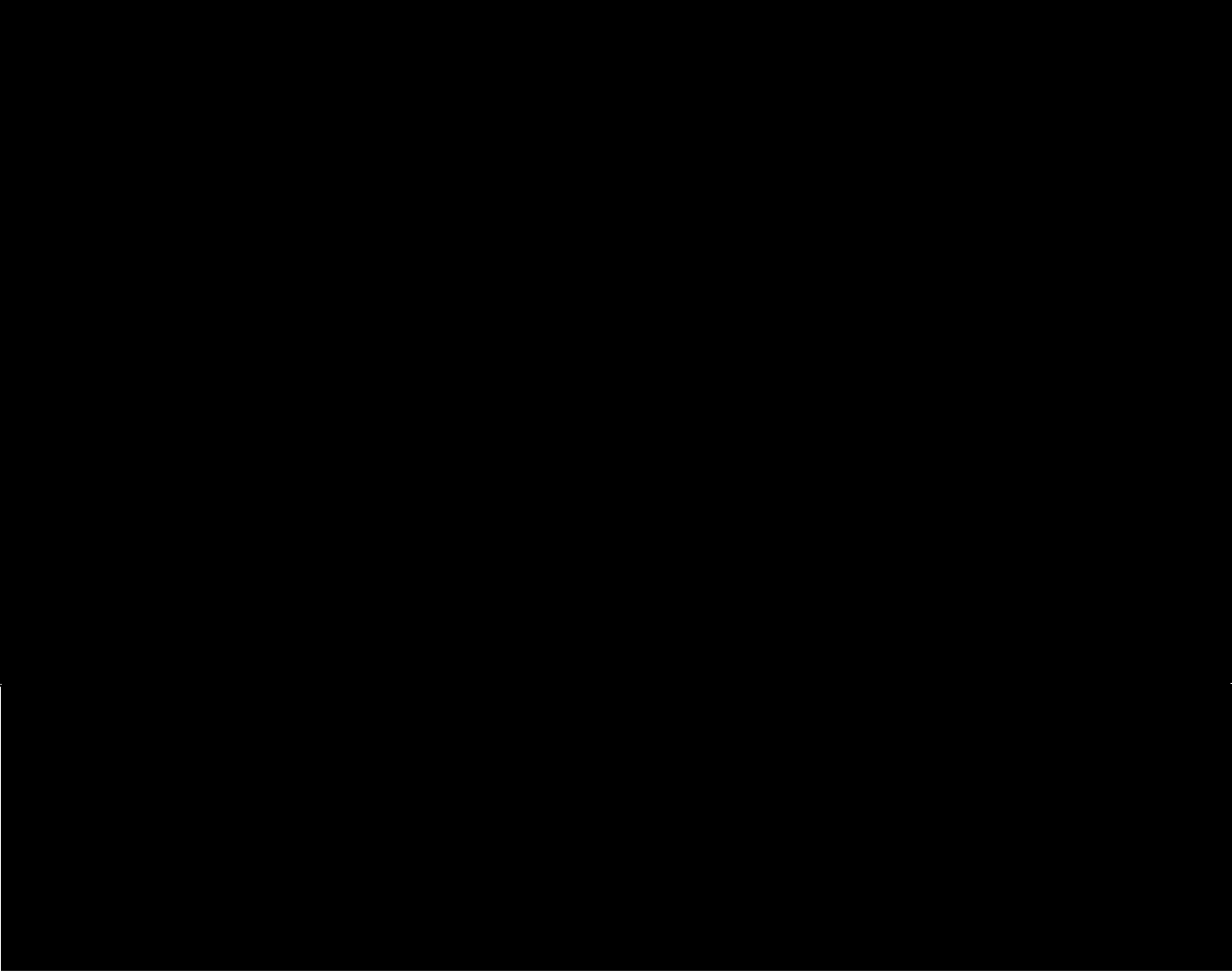
Ralph Jordan called and said that in the absence of legal council he had conferred with Frank Collins and they had agreed that the individual should have his registration suspended and he should be removed from the Sea Base immediately.

Approximately 5:30p.m.

I called Robert Kerns into my office with Stu Cottrell as a witness and read the letter of suspension to him with accompanying \$5.00 refund of his registration fees. I informed him that he must leave the Sea Base property and be on the 7:45 bus. He asked what the "charges" were. I stated that no charges had been made but certain facts had been presented to me that led me to suspend his registration and relationships with the Boy Scouts of America. He was then accompanied to his room to pack by Darrell Lenamond and Stuart Cottrell.

Approximately 6:30p.m.

He was packed and taken to the Greyhound Bus Station in Islamorada by Stuart Cottrell and Edward Heck.

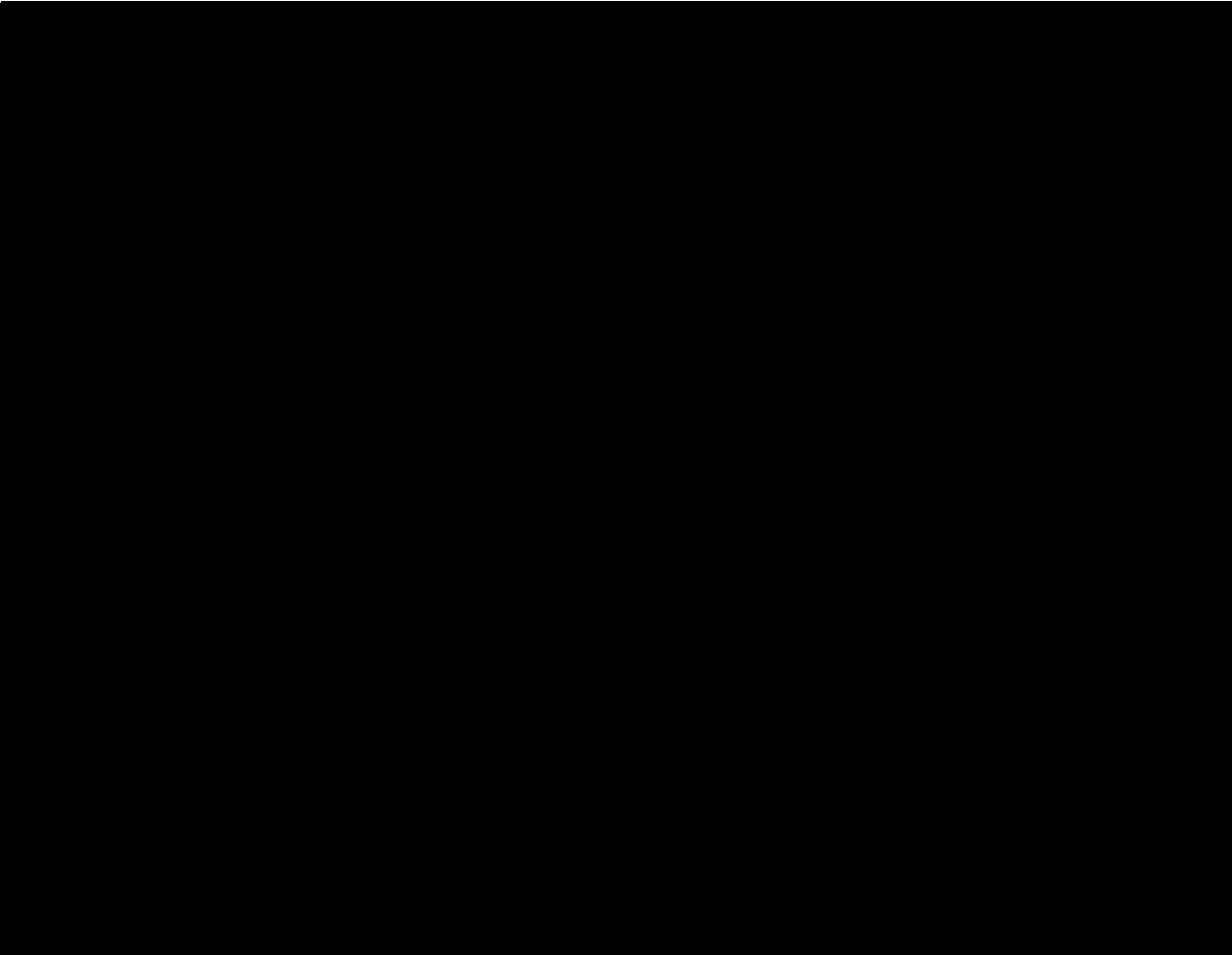

members pants while he (the staff member)
was asleep."

Doc's response was to deny the charge.
I also mentioned that other staff members had
told me Doc had been asked to leave
camp in 1980 based on a similar accusation.
~~Doc~~ Doc continued he'd been asked to leave,
but ~~had~~ denied that there was anything
to that accusation.

I then asked him if he'd be willing to face his accusers, & he said he would.

I met again with Doc, [redacted] & [redacted] the morning of June 30. [redacted] repeated the same story, Doc denied it, I then asked both if they'd be willing to take a lie detector test, making it clear we (the council) would not and did not require it, only that we would give them that opportunity. Both responded they would.

I then called [redacted], to who instructed me that [redacted] would be tested the morning of July 6.

[redacted] advised me ~~that~~ on July 6 that [redacted] had passed.

I then met again on that day with Doc and [redacted]. I advised Doc of the results of [redacted] tests, and asked if he could change his story, he repeated his denial of the charge, and asked to take a polygraph himself. [redacted] called and set it up for July 8. I informed Doc that we were still not accusing him of anything, but that due to the nature of the current evidence I would ask that Doc leave camp until we could clear the matter up.

NARRATIVE: RE ROBERT KEENE

7-7-83

My first knowledge of a possible problem
came from a remark by [REDACTED] ^{June 26} who
told me it. I "heard the rumor that Doc
(Robert Keene) was gone." I responded I
hadn't, and he replied "I'll stop it" because he
wants wish me, and they're not going to say
that.

A short time later [REDACTED] came to me
with [REDACTED], and stated at [REDACTED] the [REDACTED]
camp last summer, he [REDACTED] Doc, (Robert Keene) and one
or two others stayed over at the health lodge to
help [REDACTED] on some work projects.

He stated he "woke up one night to find
Doc's hand in his pants." He further stated he
got up and went into the other room without
saying anything, and had not mentioned it to

Doc ^{agreed} ~~agreed~~ and left.

The morning of July 8 [redacted] called to tell me Doc had failed his test.

I then received a call from [redacted] informing me Doc had just left his house and agreed to resign, and wanted a chance to tell the staff why he was leaving.

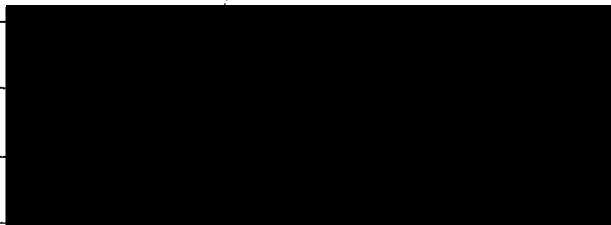
I met with Doc when he arrived at camp, and he and I agreed on the following:

a) it would not be in the best interest of Doc or the staff for him to tell them why he was leaving.

b) I would tell the staff that Doc left to honor his regional Explorer commitment and because of the rumors he felt he was ineffective.

c) I also stated again that he was not being accused of anything, but that we did have polygraph evidence that supported the belief that he had been less than truthful with us.

Doc left camp the evening of July 8.

Basis for Investigation:

[REDACTED], Director of Camping, contacted Cannon Protective Services, Inc. [REDACTED] reported that a camp staff member had been suspected of making a homosexual advance toward a boy scout.

Arrangements were made to interview and administer polygraph examinations to the victim, [REDACTED] on July 6, 1983.

[REDACTED] was interviewed by a polygraph examiner and rendered a written statement. [REDACTED] advised that he was at summer camp in 1982 in Athens, Texas. [REDACTED] stated he was awakened one night and found Camp Staff Member Robert Kearns had his hand inside of his underwear touching his private parts.

A polygraph examination was administered and it was the opinion of the examiner that [REDACTED] was truthful in his statement.

On July 8, 1983, arrangements were made to interview Robert Kerns.

Robert Dale Kerns (Social Security Number [REDACTED])

During the pretest interview Kerns denied that he had put his hand

inside the pants of [REDACTED].

A polygraph test was administered and it was the opinion of the examiner that Kerns was not truthful when he denied this.

When confronted with the deceptive response, Kerns provided no reasonable explanation for these reactions.

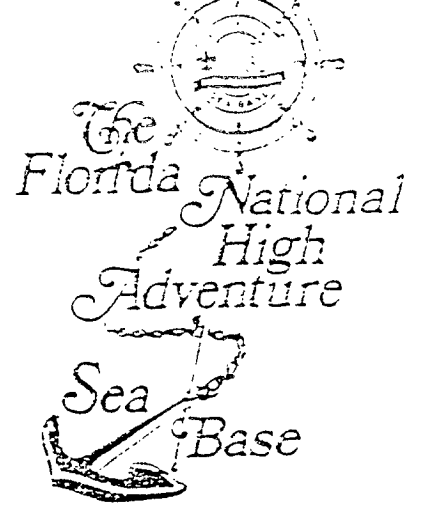


Dear Mr. Kerns:

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a national council review committee, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

THE FACTS:

A 24-year-old staff member serving as the Sea Base medical technician and as a dive instructor had his registration suspended this week and was asked to leave the base following allegations from other staff members involving sexual improprieties.

Wampler says the man was not fired, and no charges were filed.

Apparently a 17-year-old counselor in training reported to his supervisor that the individual in question had fondled him after he accepted an invitation to sleep in the 24-year-old's air-conditioned quarters (counselors in training share space with Scout and Explorer crews in un-airconditioned buildings).

The 17-year-old's superior had dismissed earlier allegations by at least one other 17-year-old counselor in training involving the same scenario.

The supervisor and the first 17-year-old mentioned went to Wampler at this point and the 24-year-old was confronted with the allegations.

Wampler says the man was on his staff for 5 seasons, was well liked, and had baby sat his children many times. Wampler stated Ralph Jordan has the file on this case.
