

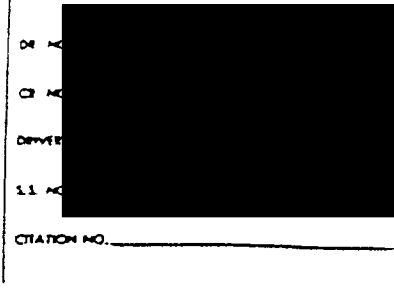

SUPPLEMENT - DETECTIVE MATUSZAK

On July 7, 1986 I contacted witnesses [redacted] and [redacted] and interviewed them regarding this incident. I also spoke to [redacted], the mother of [redacted] about suspect Smith. The boys, who were interviewed separately, provided me with the following statement.

STATEMENT: [redacted]

[redacted], in essence, told me that he, [redacted], and victim [redacted] were inside Smith's bedroom when the crime occurred. The three boys, age 15, 14 and 12 respectively, had intended to sleep over at assistant scoutmaster Robert Smith's house (where Smith lives with his parents) and leave from his residence in the morning to go on a scouting trip.

[redacted] said he and [redacted] were laying on the floor in their sleeping bags while victim [redacted] and suspect Smith were on top of Smith's bed. [redacted] could not recall what any of them were wearing or if they were laying inside their sleeping bags. After watching television for a while, suspect Smith turned it off. [redacted] could not recall if the lights were off or on, but a short time later he noticed some movement on Smith's bed and saw Smith on top of victim [redacted]. [redacted], again, was unable to recall whether the suspect or the victim were inside the sleeping bag, but he recalled the suspect reaching towards the victim's genital area. [redacted] recalled the victim saying something similar to, "Come on, stop it fag", but the suspect continued to grab at him. [redacted] assumed that victim [redacted] concluded that the suspect was kidding around, but when he would not stop, [redacted] saw that he became genuinely concerned and recalled him saying "stop it" to the suspect. When [redacted] looked up again he noticed that the victim was crying. [redacted] did not see or hear the suspect strike the victim and concluded that he was not crying as a result of a physical injury.

[redacted] said the following day when the group went on a scouting trip, he recalled the suspect threatening to make the victim pay for alleged damage done to his swimming pool by the victim throwing rubber bands in it on a previous occasion. [redacted] also recalled the suspect paying an unusual amount of attention to the victim, buying him milkshakes, etc., on the trip.

[redacted] said the suspect has never touched him inappropriately. [redacted] had never spent the night at the suspect's residence before.

After speaking to [REDACTED], I interviewed witness [REDACTED] who, in essence, explained the sleeping arrangements at the suspect's residence in the same way that [REDACTED] had described. [REDACTED] however, recalled that the boy's were wearing cut-offs or gym shorts because they had earlier intended to go swimming. [REDACTED] was also unable to recall if the boys were laying inside or on top of their sleeping bags. [REDACTED], in essence, said he was sleeping when he heard some noise and looked up to see the suspect roughhousing with the victim. [REDACTED] said from his position in the room he did not see exactly what the suspect and victim were doing, but he did recall the victim saying something similar to "come on, Bob, quit doing that, don't do that." [REDACTED] said he later looked up to see the victim curled up in a ball as if he wanted to be left alone. [REDACTED] also went on the scouting trip the next day, but did not recall any interchange between the victim or the suspect.

STATEMENT:

[REDACTED] is an adult member of the scout troupe that the boys and the suspect belong to. She described suspect Smith as "unusual" or "weird". [REDACTED] went on to say that she believes suspect Smith has many problems. [REDACTED] told me that Smith would call her on a daily basis to discuss family and other problems. She further told me that Smith would often speak of all the girlfriends he had, but [REDACTED] knew that Smith, in fact, had no girlfriends. [REDACTED] also described suspect Smith as very immature. She recalled an incident approximately one year ago when suspect Smith on a scouting trip with Boy Scouts was pushing some of the scouts in a swimming pool. When the scouts got together and pushed Smith in the pool, she recalled him sobbing like a child and wanting to go home. (Smith is 21 years old.)

[REDACTED] also recalled the suspect telephoning her from the County jail on the day he was arrested. [REDACTED] said suspect Smith told her he had been arrested and he would have to give up his job as assistant scoutmaster. Smith did not deny the charge nor explain his involvement with the case to [REDACTED].

14 Q Did your mom hold the phone over to you so you could

15 hear what was being said by Mr. Smith?

16 A No, I was sitting next to her where the phone was, and I

17 heard everything.

18 Q And that was, you said, on a Wednesday night after the

19 trip, after that weekend?

20 A Uh-huh (affirmative).

21 Q Is that the first time, [REDACTED] you had told anybody Mr.

22 Smith had touched your penis on this night you stayed over at

23 his house?

24 A I didn't tell my mom before; I didn't tell anybody

25 except those other two kids, [REDACTED] they were the

26 first to know.



1 Q And did either [REDACTED] talk to you about what had  
2 happened the same night that you were sleeping on the bed?

3 A No, the next day, on the way back from the river trip,  
4 [REDACTED] was talking to me, that I should tell my mother, and I  
5 told him I would, and that is when everything came up.

6 Q Did --

7 A After the trip, I waited a couple of days, and then  
8 when Robert E. Smith called again, he -- he was talking about  
9 something else, telling people the joke -- that it was a joke,  
10 and that Wednesday I finally told my mom.

11 Q When you went on the trip, had you talked to [REDACTED] about  
12 what had happened in the bedroom that night, the night before?

13 A No, I only talked to [REDACTED]

14 Q Had [REDACTED] woken up when whatever happened on the bed  
15 happened?

16 A Well, [REDACTED] woke up.

17 Q Did you talk to [REDACTED] after he woke up?

18 A No, I didn't.

19 Q Did you talk to [REDACTED] after you woke up?

20 A No, I didn't.

21 Q Do you know whether they went back to sleep right away  
22 after they woke up?

23 A No.

24 Q So, you didn't talk to them or look at them to see  
25 whether they were staying awake or not?

26 A All I said is that -- I said stop, he is grabbing my --

8 spot on the floor next to the door, and I said I will just

9 lay my sleeping bag there, but Robert said, "I get up in the

10 middle of the night, and I might step on you; you might have

11 to sleep on my bed," so that is how I ended up on there.

12 Q It wasn't -- wasn't your idea to put your sleeping bag

13 on the bed?

14 A No, it wasn't.

15 Q Do [REDACTED] -- do they live in Redwood City, too?

16 A I think so; I don't know -- wait -- [REDACTED] -- yeah, they

17 both do.

18 Q Do they live near where you live?

19 A Not too far away; about -- pretty close.

20 Q You say you first met Robert a month ago; is that when

21 you first joined this Troop 199?

22 A When I first joined the troop, I met Robert.

23 Q Had you been in scouting before you jointed Troop 199?

24 A Yes.

25 Q What other troop had you been in before that?

26 A Troop -- I can't remember the -- Troop 127.

1 Q That was a Redwood City troop, also?  
2 A No, that was Calabasas troop.  
3 Q You moved to Redwood City, then, right?  
4 A Yes, I did.  
5 Q When you were sleeping in your sleeping bag, did you  
6 have your jeans on?  
7 A I had my bathing suit on, a pair of shorts.  
8 Q You had a pair of shorts on?  
9 A Bathing suit.  
10 Q Did you have anything over your bathing suit, like pants?  
11 A (Nodding in the negative.)  
12 THE COURT: Again, don't just shake your head; answer  
13 with a word.  
14 THE WITNESS: No -- no.  
15 MR. PACKARD: Q Did you have any pants on over  
16 your swimming suit when you were in the sleeping bag?  
17 A No.  
18 Q Did you have any other clothing on besides your swimming  
19 suit?  
20 A Shirt.  
21 Q The -- Marta asked you some questions about whether  
22 you were touched in your -- by Robert with his hand on your  
23 penis, and you said he touched you over your sleeping trunks  
24 and under your sleeping trunks?  
25 A Both.  
26 Q The first time was touching on your sleeping trunks?

1 A Yeah, he went -- what he did, beginning, he went down my  
2 sleeping bag, and touched over them, and then -- after he  
3 stopped that part, he went in, and that was it, then after  
4 that, he stopped.

5 Q OK. When he touched over your sleeping -- or your  
6 swimming trunks, was he moving his hand, at all?

7 A Yes, he was.

8 Q Was he pinching or moving it up and down?

9 A Pinching and moving around, pinching all different parts.

10 Q And when he was pinching, you said you yelled to stop,  
11 and one of the boys woke up?

12 A Yes, I did.

13 Q Did [REDACTED] say anything when he woke up?

14 A No, they didn't (sic).

15 Q When Robert put his hand under your swimming trunks and  
16 touched your penis, was he -- holding his hand still or  
17 moving his hand?

18 A Moving his hand.

19 Q And was it the same way he did it the first time, or  
20 different this time?

21 A Different.

22 Q And can you describe how the movement with his hand  
23 occurred this time?

24 A No, I can't.

25 Q You think -- but, you are sure it was different than the  
26 way he moved his hand when he had his hand on top of your

1 trunks?

2 A Yes, it was.

3 Q When he started touching you under your swimming trunks,  
4 did you yell stop, again?

5 A Yes, I did.

6 Q And did [REDACTED] wake up again, or was [REDACTED] still awake?

7 A They were just laying there; they didn't wake up. They  
8 didn't put their head up or nothing like that.

9 Q So when you yelled stop, [REDACTED] didn't wake up at that  
10 point, when he had his hand under your trunks, am I correct  
11 when I say that?

12 A -- Yes.

13 Q And did that stop after he had reached his hand under  
14 your trunks?

15 A Uh-huh (affirmative).

16 Q You know how long ten minutes is?

17 A Yes, I do.

18 Q OK. Now, from the time that he first touched you on  
19 top of your swimming trunks, until he reached under your  
20 swimming trunks and then stopped, is that period of time that  
21 you are talking about ten minutes, or was he touching you for  
22 ten minutes?

23 A He was touching me for ten minutes.

24 Q After -- from the time he first started on top of your  
25 swimming trunks?

26 A What he did was, he did -- touched the top of my trunks

1 first, for a while, and then he went down to the bottom, and  
2 it was around ten minutes that he was doing it.

3 Q Ten minutes under your trunks; is that what you are  
4 saying?

5 A Ten minutes, both.

6 Q Counting both times, both on top and underneath?

7 A Yes.

8 Q Do you know how much of that time he had his hand under  
9 your swimming trunks?

10 A No, I don't.

11 Q Did he have -- most of the time, did he have his hand  
12 outside your swimming trunks, or under your swimming trunks?

13 A Mostly on the inside.

14 Q Did you -- have you been talking to a counselor about  
15 what happened with Robert -- what he did to you?

16 A Yes, I would --

17 MRS. DIAZ: Objection, irrelevant.

18 MR. PACKARD: I can ask --

19 THE COURT: I think that question, in and of itself, and  
20 the answer is -- not objectionable. I will permit that answer.

21 MR. PACKARD: Q Did you say yes, [REDACTED]?

22 A Yes.

23 Q When I asked you about counseling?

24 Are you still seeing a counselor?

25 A Yes.

26 Q Is there a -- name of a person that you know who is

giving you counseling right now?

A Will Weeks.

MR. PACKARD: I have no further questions.

THE COURT: Any redirect?

MRS. DIAZ: No redirect, Your Honor.

THE COURT: All right; thank you, [REDACTED]; you can step

down.

(Witness excused.)

MRS. DIAZ: The People rest.

THE COURT: Any witnesses for the defense?

MR. PACKARD: No, Your Honor.

THE COURT: The matter submitted, or is there argument

from either party?

MRS. DIAZ: Submitted by the People.

MR. PACKARD: It will be submitted, Your Honor.

THE COURT: It appears to the Court each of the two offenses set forth in the complaint, violations of Section 288(a) of the Penal Code, and Section 136.1(a) of the Penal Code, have been shown by the evidence to have been committed, and it does appear to the Court that the defendant named in the complaint, Robert Edward Smith, is guilty of the commission of each of those two offenses.

He will be ordered held to answer, and to stand trial on each of those charges.

Further, it appears that the special allegation appended to Count I, as shown by the evidence, seems to be

1 true, and also is a matter which will be bound over to the  
2 Superior Court.

3 Holding the defendant to answer, it would appear that --  
4 what's the status of things here -- he is on his own  
5 recognizance, I take it?

6 MRS. DIAZ: Yes, Your Honor.

7 MR. PACKARD: I understood he had posted bail, but --

8 THE COURT: Have you posted bail in this matter, Mr.  
9 Smith?

10 THE DEFENDANT: My father posted bail, Your Honor.

11 THE COURT: Any reason he should not remain on the bail  
12 that has been set, Mrs. Diaz?

13 MRS. DIAZ: What is the bail, Your Honor?

14 THE COURT: I don't know.

15 MR. PACKARD: \$5,000 or \$10,000.

16 MRS. DIAZ: I think that is adequate.

17 THE COURT: Defendant will remain free on the bail  
18 posted in this matter, and I am looking at the 14th of August  
19 as a date for first appearance in the Superior Court; is that  
20 agreeable?

21 MR. PACKARD: Excuse me -- I think that is -- could I  
22 ask the week of the -- would the Court set August 22nd? I  
23 know that is somewhat long.

24 THE COURT: I don't think that is any big problem.

25 Mr. Smith, the date your attorney is suggesting for your  
26 first appearance is a little more than a week beyond the time



1 within which you are entitled to make your first appearance  
2 in the Superior Court. Will you waive your right to an early  
3 appearance date and agree I may set the matter on the date  
4 your attorney has requested?

5 THE DEFENDANT: Yes, Your Honor.

6 THE COURT: Then you will be directed to appear on  
7 August 22nd, 9 o'clock, in the Superior Court for this county  
8 in the Hall of Justice and Records in this building before the  
9 Presiding Judge of the Criminal Department of the Superior  
10 Court.

11 You will remain free on the bail you have posted.

12 MR. PACKARD: Thank you, Your Honor.

13 MRS. DIAZ: Thank you, very much, Your Honor.

14 THE COURT: Thank you.
