You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

ATTACHMENT TO LETTER

The following information is provided should you desire a review by the South Central Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: Richard Bentley, South Central Region, BSA, Irving, Tx 75015-2325. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.

Upon arrival we spoke to Case Worker, Cathye Bullitt (See RP). RP stated the victim's mother [redacted] had brought the victim [redacted] to her office to report an alleged sexual assault of a child. Mrs Bullitt introduced us to [redacted] [redacted] stated she is a [redacted] elementary, Sheppard Air Force Base. [redacted] stated on or about August 21, 1990 she was working at the school. [redacted] said [redacted] had accompanied her that day. [redacted] told us [redacted] had informed her that a janitor, later identified as Ronald Eugene Bussey, had played games with her and her friend [redacted]

[redacted] who was also present at the school. The janitor had taken the two girls to the computer room at the school in continuation of the game. He put [redacted] on his lap, put his hand inside her pants and panties. He rubbed his hand against her anal and vaginal areas. He let [redacted] get up and look-out for aliens, he (adult) in the continuation of the game. While [redacted] was watching the door he had [redacted] on his lap and he put his hands down her pants and panties. He rubbed [redacted] anal and vaginal areas. He then had [redacted] watch the door and [redacted] was put back on his lap. He again, did the same acts on each girl another time. When the game was over he whispered "I'm sorry" to the girls. The girls returned to [redacted] room. [redacted] fields the incident happened at approx 11:00 am. While we were interviewing [redacted], Cathye Bullitt conducted a video interview concerning the elements of the crime with the victim. When Cathye finished the video interview she brought [redacted] into the office with and introduced her to us. [redacted] told us she had wanted to tell her mother about the incident because she had been afraid her mother may not believe her because she believed the janitor had a close relationship with the teachers in the

NARRATIVE/SUPPLEMENT CONTINUATION: school [redacted] mother stated she had been suspicious of the subject before and that another teacher had approached the principal regarding her suspicions and the principal had taken no action. We then viewed the video. In the video, [redacted] statement had no apparent discrepancies from the statement given by [redacted].

The suspect Ronald Eugene Bussey did intentionally and knowingly engage in sexual contact with a female child (not his spouse) with the intent to gratify or arouse his sexual desire.

The video tape made by Cathye Billitt will remain in her possession in the office Protective Services located at [redacted]. Because an alleged offense occurred on federal property the office of special investigations was notified.

After leaving [redacted] office we were contacted again at approx 1400 hours. Upon our arrival we found Mr. Ronald Bussey at her office. [redacted] related to us that the course of her civil investigation Mr. Bussey stated he had committed the offense alleged by the victim. He told [redacted] he wanted to speak to police officers. Officer Jenkins and I transported Bussey to Judge Luther B. Williams to be informed of his legal rights. After being informed of his rights, Bussey on his own will, went to the

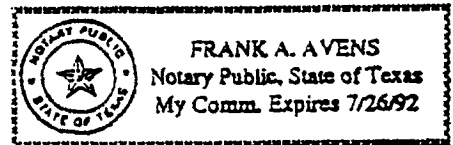
