REPORT OF INCIDENTS 29 JULY, 31 JULY, and 1 AUGUST 1971

The morning of Munday 1 August assistant Scoutmaster , Troop 31 reported to me that a number of his Scouts had had homosexual advances made to them by Ron Wentworth, camp maintenance director. Discussion with the individual Scouts disclosed the following:

During the afternoon of Thursday 29 July an umber of Scouts had been helping Ron Wenterth hault canvas to the dump from the building Troop 31 was removing. While on the barge and say that Roh wentworth was holding them with his hand on their genitals, re orts that he did it 5 or 6 times, stroking, and that reports that he did it twice, andthat pushed him : way. 📹 said, "Lay off," to make his stop. reports he was sitting beside him at the time, and that said, "Help," and moved away weports he was asked to sit on kon's lap, and that cheld his genitals for several minutes. of the Scouts in the troop were aware of what had happened and were discussing it among themselves. (Dwight Henninger is a member of troop 15, company with Troop 5.) Not Souts been Rom were serry for him, a graph During the morning I interviewed the Scouts, except with present. After contacting Sout Exec tive Robert for ton, I presented the facts, without names, to him wentworth. He was stocked, denied any wrongdoing, said he meant nothing by the horse-lay, no sexual implications were intended, and that at most had as indiscrept in engaging in contact roughhousing with the Scouts. He offered to leave camp quickly and quictly.

By the time the leaders of Troop 31 were aware of this, almost all

After discussion with it was determined to try to find out for sure whether Ron was guilty or not before letting him leave camp, and to seek the guidance of Executive Board Member Larry Henninger before making a final decision.

Ron if the final the final the final transfer was advised to seek counseling, agreed to leave camp immediately, and also said he would talk to Robert Horton. Mr. was with me when we talked to Ron.

Late in the afternoon I met with the following committee members of Troop 31 who were in camp: Sterling McNeese, Dick Rogers, Bill Schick, Gil Johnson, and assistant Scoutmasters Bob Bodd, and Jim Cox. It was agreed that the correct course of action had been taken, that the committeemen would notify the marents, and that he Scouts would be advised not to talk to any other troop members. Some Scouts were going home with parents, but not those involved.
