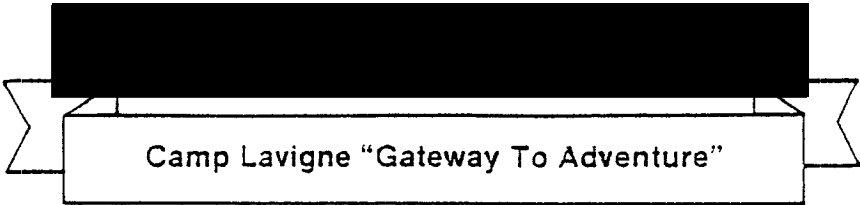

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within sixty (60) days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for review are attached.

[REDACTED] appeared before the committee of Boy Scout Troop 13 on May 9, 1989.

The following committee members and leaders were present: George M. Griffin, chairman; Bernadette Abrams, member; Joseph Snyder, member; Carol Griffin, member; and Scott Price, Scoutmaster.

[REDACTED] informed the committee that she had recently learned that Ronnie D. Whitenight [REDACTED] had sexually molested [REDACTED] now age 20, while he was in his teens and that she was bringing this information to the committee so that they would not expose Scouts to potential molestation by Mr. Whitenight.

Mr. Griffin then wrote on behalf of the committee to Mr. Whitenight. This letter was mailed on May 17, 1989, and was sent as a certified letter which Mr. Griffin states that Mr. Whitenight did receive. Mr. Whitenight did not respond in any way to the Troop 13 letter, according to Mr. Griffin.

The Scout Executive was not informed of this situation until September 13, 1989.

The information regarding [REDACTED] statement was provided by Mr. Griffin and Scoutmaster Scott Price. Mr. Griffin verified the names of the committee members and leader present at the May 9, 1989 meeting.

Dear Mr. Whitenight:

Please be advised that during the May 1989 B.S.A Troop #13 council meeting, a person identifying herself as [REDACTED] statements that demeaned your character and raised questions of your morality. Purportedly she sent you written notice of her allegations and thus it serves no purpose to delve into those particulars.

More importantly, you understand that the allegations are serious in nature and any suspicion(s) that may adversely affect the troop require action that responsibly and reasonably deal with the situation. At this point in time we are deeply concerned, trying to be non-judgemental and hopeful this matter is not one that proves damaging to the organization. You have contributed greatly to this troop and while we are appreciative, we must consider the welfare of these young men.

Therefore, we as a body, voted to have you abstain from direct participation in Troop #13 functions until such a time we are formally notified of a withdrawal of complaint or other proof of vindication.

The alleged molestation evidently happened some years previously. His mother stated that he had just come forward with the incident. One concern related to AIDS for which he may have been tested. [REDACTED] at his mother's request.

NOTE: Children & Youth Services reports on 9/19/89 that as they have established that [REDACTED] is now 20-years of age, no action may be taken under PA statutes. [REDACTED] was advised by caseworker who contacted her that she and her son may make a criminal complaint, however, if they wish to take action against Ron Whitenight. Childre n & Youth will pursue no investigation.
