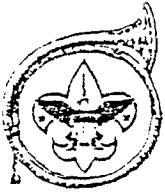





Russell Appler entered a guilty plea on March 20, 1990 before Judge Gavin. Mr. Appler's guilty pleas were for eight separate offenses covering four separate criminal complaints. On each criminal complaint Mr. Appler pled guilty to indecent exposure and corruption of minors. The guilty plea colloquys and sentencing records indicate that the defendant was placed on five years probation for each corruption of minors charge concurrent with each other. Concurrent to the corruption of minors charges, the defendant also received two years probation on each indecent exposure charge, each two year probationary period to be served concurrent to each other. Hence, in effect, the defendant, Mr. Appler will be serving a five year term of probation. If Mr. Appler violates his probation within the first two years he can be found in violation of all eight charges and resentenced on all of them. If Mr. Appler is found to be in violation of his probation between the second and fifth year then he will be subject to being violated on only the four counts of corruption of minors. Mr. Appler was also sentenced to pay a \$10.00 fine on all eight offenses as well as the cost of prosecution and have no physical contact with children under the age of fifteen, other than his own. Additionally, as a special condition of his probation Mr. Appler was ordered to enter and successfully complete a sex offender's program to be monitored by the Adult Probation Department. Complaint affidavits, sentencing sheets from the Clerk of Courts' Office and pages of the guilty plea colloquy form which Mr. Appler signed indicating and documenting the aforementioned facts are attached to this memo.

den wearing a [redacted] robe. [redacted] then went to ask her father, Russell,
if [redacted] could spend the night at there residence. At this point,
Russell Appler, the defendant lifted up his robe with his hand and
exposed his genitals to [redacted] stated that he lifted the
robe up to his waist and kept holding the robe up for approx 5 minutes.
[redacted] stated that she became very nervous and kept trying to look
away. The defendant then asked [redacted] if she wanted to sleep over.
He then asked her what type of games she liked to play. [redacted] stated
that Mr Appler put down the robe a couple of times but then pulled the
robe back up. [redacted] was 10 yrs old at the time of the incident.

Incident Report

On Tuesday, September 26, 1989 [REDACTED] and [REDACTED] met with me in my office. [REDACTED] stated that in the previous week her 9 year old daughter acknowledged that she had been molested 2 years earlier by Russell Appler.

The incident occurred during a Girl Scout Brownie meeting at the Appler home. [REDACTED] was serving as the Girl Scout Leader. During the course of the meeting, Mr. Appler lured [REDACTED] to their upstairs bedroom where he molested her.

According to the mother - "he did everything imaginable except rape her". Since then both parents and teachers noticed personality changes in the child. The mother did seek professional help and the counselor was the individual who made the report to the State and recommended disclosure to the Girl Scouts and Boy Scouts.

I informed [REDACTED] that we needed the report from the State Child Welfare Department for our records. I have further communicated with Teri Kaly, Executive Director of the Freedom Valley Girl Scout Council.

Schuylkill man charged in child molesting incidents

SCHUYLKILL — Police arrested a township man Thursday and charged with attempting to rape a 7-year-old girl and indecently exposing himself to two 10-year-old girls, according to court affidavits.

Russell C. Appler, 64, of Oakwood Lane, Valley Forge, was charged with the attempted rape after his victim, now 10, told her parents about the assault last month, according to affidavits filed with District Justice John T. Jeffers of Phoenixville. The incident allegedly occurred in 1986.

Appler was also charged with indecently exposing himself to the two 10-year-old girls while they were visiting his home during the summer, according to the affidavits.

Chester County Detectives Lt. Michael Cotter said the investigation is continuing.

Appler was arraigned before Jeffers and was released Thursday af-

ternoon after he posted \$5,000 bail.

According to a search warrant filed with Jeffers, Appler admitted to police that he was involved in two indecent exposure incidents. He also told police that he was seeing a doctor about the incidents, according to the search warrant.

Appler's wife, Linda, told police that Appler had seen a doctor after "similar" incidents that occurred in the 1940s and 1950s, according to the search warrant.

Police said in the search warrant that Appler was arrested for the earlier incidents. Details of the earlier incidents were not included in the search warrant.

According to the affidavits, Appler attempted to rape the 7-year-old girl in September or October of 1986.

The girl told police that she was looking at plaques hanging on a hallway wall in the suspect's home when she asked her to come into his bedroom, according to the affidavits.

The girl went into the bedroom and

the suspect allegedly attempted to rape her there, according to the affidavits.

The girl escaped from the room but not before the suspect allegedly slapped her, kicked at her and threatened her and her parents, according to the affidavits.

The suspect also exposed himself to the girl on another occasion, according to the affidavits.

Appler was charged with criminal attempted rape, indecent assault, simple assault and three counts each of indecent exposure and corruption of minors for the incidents, according to affidavits.

He was charged with four counts each of indecent exposure, corruption of minors and endangering the welfare of children for allegedly exposing himself one time to one 10-year-old girl and three times to another 10-year-old girl, according to the affidavits.

All of the incidents allegedly took place during the summer.
